1 Introduction

Jacobs Group (Australia) Pty Ltd (Jacobs) was commissioned by the Department of Planning, Industry and Environment (DPIE) to undertake a Preliminary Contaminated Site Investigation (PCSI) of the Frenchs Forest Planned Precinct located at Frenchs Forest, NSW (referred to hereinafter as the site).

The location of the site is presented as Figure 1.

Jacobs understands that DPIE intends to prepare a draft Precinct Plan for the site and that this plan will contain a rezoning package including detailed development controls and an infrastructure plan. A Preliminary Site Contamination Investigation was undertaken in order to inform the draft Precinct Plan and assist in meeting DPEs obligations under State Environmental Planning Policy No. 55 Remediation of Land (SEPP 55).

This report details the works undertaken during the PCSI at the site including a review of available information and field observations.

This report has been prepared in general accordance with the requirements specified for a Preliminary Site Investigation as detailed in the NSW EPA (1997) *Contaminated Sites: Guidelines for Consultants Reporting on Contaminated Sites.*

2 Objectives and Scope of Works

2.1 Objectives

The objectives of the PCSI were:

- To identify and document the potential for land contamination, based on a review of current and historical activities undertaken within and/or adjoining the site
- To comment on the suitability of the land for development including the potential for the land to be made suitable through remediation and any areas not suitable for development.

2.2 Scope of Works

The scope of works undertaken to address the objectives are detailed below.

A desktop contamination assessment was undertaken which included a review of information (where available) from the following sources:

- NSW EPA Contaminated Land Record of Notices
- NSW EPA List of NSW Contaminated sites notified to the NSW EPA
- NSW EPA Protection of the Environment Operations Act Public Register
- · Historical aerial photographs
- Topographic and/or orthophoto maps
- Geology and soil maps
- Available hydrogeological information
- Other information pertaining to potential contamination as detailed in the Environmental Risk and Planning Report (Lotsearch, 4 December 2017).

A site inspection was undertaken to assess potential contaminating activities undertaken within and/or adjacent to the site.

This report was prepared detailing the results of the desktop assessment and the site inspection.



3 Site Setting

The site information presented below is based on a review of readily available government information sources and information provided by DPIE.

3.1 Site Identification

The site has been defined spatially as:

- Areas adjacent to and to the north of Frenchs Forest Road
- Areas to the west of Wakehurst Parkway
- Areas adjacent to and to the south of Warringah Road and extending south west to Fitzpatrick Avenue
- Areas including, adjacent to and to the east of Forest High.

The site is located within the local government area (LGA) of the Northern Beaches Council.

3.2 Site Zoning and Land Use

At the time of undertaking the PCSI, the site was occupied by a combination of land uses including:

- Roadways (operational and under construction)
- The Northern Beaches Hospital (under construction)
- Ancillary construction sites
- The Forest High School
- Residential premises.

The zonings of the site under the Warringah Local Environment Plan (LEP) 2011 were:

- RE1 Public Recreation
- R2 Low Density Residential
- SP2 Infrastructure
- B1 Neighbourhood Centre.

3.3 Topography and Drainage

The site topography can be characterised as a plateau landform with localised gentle undulations. Areas adjoining the site are characterised by steep topography. The site is covered by both unsealed (grassed areas, open space and areas of earthworks) and sealed areas (hospital and school associated buildings, footpaths and roadways). Water falling onto the unsealed areas of the site is likely to infiltrate directly into site soils. Rainfall falling onto sealed areas within the site are likely to be discharged directly into formal drainage structures (e.g. concrete kerb and guttering, formalised storm water pits) and discharge to the local storm water system.

3.4 Hydrogeology

In consideration of the topography of the site and surrounding areas, the site is likely to act as a watershed with the anticipated groundwater flowing in a northerly, southerly and westerly direction towards Trefoil Creek (to the north), Main Creek (to the south) and Carroll Creek (to the west). Shallow groundwater beneath the site is



expected to be perched above the residual weathered bedrock and to be recharged predominantly by the infiltration of surface water falling onto the unsealed surfaces of the site.

Based on information from the Lotsearch (4 December 2017), the aquifer beneath the site is described as porous, extensive aquifers of low to moderate productivity.

The Lotsearch (4 December 2017) search of the NSW Department of Primary Industries – Office of Water registered groundwater bore database indicated that a number of registered groundwater wells are located on and within 1km of the site. Details of the registered groundwater wells located on and adjacent to the site (i.e. within 1km) are provided in **Table 3.1**.

3.5 Geology

Reference to the Sydney 1:100,000 geological series sheet 9130 indicates the majority of the site is underlain by Wianamatta Group shale and laminate with small areas within the north western and south western portions of the site underlain by Wianamatta Group Hawkesbury Sandstone (Rh) comprising medium to coarse grained quartz sandstone with very minor shale and laminite lenses.

3.6 Soils

Review of the Sydney 1:100,000 soil landscape series sheet 9130 indicated that the site is underlain by the Lucas Heights soil landscape.

The Lucas Heights (Ih) soil landscape is characterised by residual moderately deep, hardsetting, yellow podzolic and yellow soloth soils, yellow earths on outer edges of crests. The limitations of this soil landscape include stony soils, low soil fertility and low available water capacity.

The CSIRO (2011) Australian Atlas of Soils describes the soil landscape beneath the site as:

Dissected sandstone plateau of moderate to strong relief with sandstone pillars, ledges, and slabs level to undulating ridges, irregularly benched slopes, steep ridges, cliffs, canyons, narrow sandy valleys: chief soils are (i) on areas of gentle to moderate relief, acid yellow leached earths (Gn2.74) and (Gn2.34) and acid leached yellow earths (Gn2.24)-sometimes these soils contain ironstone gravel; and (ii) on, or adjacent to, areas of strong relief, siliceous sands (Uc1.2), leached sands (Uc2.12) and (Uc2.2), and shallow forms of the above (Gn2) soils. Associated are: (i) on flat to gently undulating remnants of the original plateau surface, leached sands (Uc2.3), siliceous sands (Uc1.2), sandy earths (Uc5.22), and (Gn2) soils as for (i) above (these areas are in part comparable with unit Cb29); (ii) on flat ironstone gravelly remnants of the original plateau surface, (Gn2) soils as for unit Mb5(i); (iii) on gently undulating ridges where interbedded shales are exposed, shallow, often stony (Dy3.41), (Dr2.21), and related soils similar to unit Tb35; (iv) narrow valleys of (Uc2.3) soils flanked by moderate slopes of (Dy3.41) soils; (v) escarpments of steep hills with shallow (Dy) and (Dr) soils between sandstone pillars; and (vi) shallow (Um) soils, such as (Um6.21) on steep hills of basic rocks. As mapped, minor areas of units Mg20, Mm1, and Mw8 are included.

3.7 Acid Sulfate Soils

Acid sulfate soils (ASS) are the common name given to naturally occurring sediments and soils containing iron sulfides (principally iron sulfide or iron disulfide or their precursors). The exposure of the sulfide in these soils to oxygen by drainage or excavation leads to the generation of sulfuric acid. Areas of ASS can typically be found in low lying and flat locations which are often swampy or prone to flooding.

A review of the ASS risk maps from the Warrigah LEP (2011) indicated that the site is not within an area classified as an ASS risk.



4 Information Review

The site history has been sourced from publically available information and the *Environmental Risk and Planning Report* (Lotsearch, 4 December 2017) commissioned by Jacobs. The Lotsearch (4 December 2017) report is provided in **Appendix A**.

The information reviewed and summary of the results in the context of contamination risk is provided in **Table 4.1**. Contamination risks have been assessed as high (if present on site), moderate (if present within 500m of the site), low risk (if greater than 500m and less than 1km from the site) and no risk where there were no relevant records or information was not relevant with respect to contamination.

Businesses with potential contaminating activities are based on those industries detailed in the Australian Standard *Guide to the sampling and investigation of potentially contaminated soil. Part 1: Non-volatile and semi-volatile compounds* (AS 4482.1-2005).

4.1 Aerial Photography

Aerial imagery was reviewed for the years 1943, 1956, 1961, 1965, 1970, 1982, 1991, 2005, 2009 and 2016 to assess land use and changes in general conditions within and adjacent to the site. The findings of the aerial imagery review are summarised in **Table 4.2**. Historical aerial imagery is presented in the Lotsearch (2017) report provided in **Appendix A**.

4.2 Parish Maps

Parish maps for Manly Cove (dated 1969) were reviewed. The information provided (with respect to the site) indicated the following:

- The Northern Beaches Hospital site was resumed for a hospital site (gazetted 13 November 1959)
- The Forest High site was resumed for a public school site (gazetted 5 June 1959).

Parish maps are provided in **Appendix B**.

4.3 Previous Investigations

The following information was provided by DPIE and Roads and Maritime Services for review:

- SMEC (October 2014) Phase 1 Contamination Assessment: Northern Beaches Hospital Connectivity and Network Enhancement Project, Frenchs Forest NSW (SMEC 2014)
- ADE Consulting Group (June 2016) Remediation Action Plan 461 Warringah Road, Frenchs Forest NSW (ADE 2016)

The results and conclusions of the previous investigations have been assessed in context of the contamination risk to the site.

1.1.1 SMEC 2014

The SMEC (2014) assessment was undertaken to assess potential contamination risks associated with the road upgrades for the development of the Northern Beaches Hospital and the broader network capacity (i.e. network enhancement works). The SMEC (2014) assessment addressed potential contamination risks associated with the construction of the road upgrades across an area which included the Frenchs Forest Planning Precinct and adjoining areas. The SMEC (2014) assessment was undertaken prior to the commencement of construction works for the Northern Beaches Hospital and associated road upgrades.

The findings of the SMEC (2014) in context of the Frenchs Forest Planned Precinct were:



- The potential presence of fill material on the southern side of Warringah Road between Hilmer Street and Fitzpatrick Avenue.
- The potential for the storage of chemicals (including fuels) in workshops and refuelling infrastructure at the Frenchs Forest Police Station
- The historical use of the Forest High School site as an orchard.
- Storage of fuels within underground storage tanks and associated infrastructure at the 7-11 service station located at the corner of Warringah Road and Hilmer Street. Information from reports predating the SMEC (2014) assessment indicated that soils and groundwater beneath the site were impacted by heavy metals and hydrocarbons.
- Historical brickwork activities undertaken on the corner (south western) of Warringah Road and Wakehurst Parkway.
- Roads and pavements across the project area could contain coal tar materials.

Other information contained within the SMEC (2014) assessment included an overview of contamination testing undertaken on the Northern Beaches Hospital site by SMEC in 2013 and Douglas Partners in 2012. No contamination was reported in the soil and groundwater samples collected as part of these investigations.

1.1.2 ADE 2016

The ADE (2016) remediation action plan (RAP) was prepared to outline guidance for the future remediation of the site (i.e. 461 Warringah Road, Frenchs Forest). The RAP was prepared based on the results from previous contamination investigations undertaken at the site as detailed below. With the exception of the SMEC (2014) report, these reports were not provided for review.

- Parsons Brinckerhoff, UPSS Validation, 7-Eleven Service Station 461 Warringah Road, Frenchs Forest, NSW (Store ID: 2220), Document No: 2201503A-CLM-RPT-1557 RevB, dated 1st of August 2014
- SMEC, Phase 1 Contamination Assessment: Northern Beaches Hospital Connectivity and Network Enhancement Project, Frenchs Forest NSW, Document No: 30011560 FINAL, dated October 2014
- Ventia, 2220-Frenchs Forest-GME Report, dated October 2015
- ADE Report No. FYJV-01-10217 / DSI / v1 final, Phase II Detailed Site Investigation for 461 Warringah Road, Frenchs Forest NSW, dated 15th April 2016.

The results of these investigations (as summarised by ADE) are provided below.

Note that at the time of preparing this report, Jacobs had not been provided with reports detailing the validation of the site in accordance with the ADE (2016) RAP. No relevant contamination information was provided for the Ventia (2015) report.

The PB (2014) investigation involved the sampling of soil from around the underground petroleum storage systems (UPSS), sampling of groundwater and evaluation of residual contamination in soil/groundwater that would preclude the site's suitability for on-going use as a service station.

The validation report concluded that residual hydrocarbon contamination existed both within the soil and groundwater after the removal of the UPSS. PB concluded that "The residual impacts, however, were not considered to pose unacceptable risks to the commercial users of the site under the site's current configuration. The validation soil results also showed no unacceptable risks to the shallow trench worker undertaking intrusive works in the vicinity of the site. Therefore, the site was considered suitable for continued use as a service

station. If the site's layout was to be changed in the future, assessment of potential vapour intrusion risks would be necessary to confirm the site's suitability under the layout of the new development."

PB (2014) noted that three underground storage tanks (USTs) remained in-situ, a liquefied petroleum gas UST (located central portion) and two USTs (located in the eastern portion).

The ADE (2016) investigation indicated three areas on-site which posed contamination risks, as detailed below.

Area of Concern 1 - TRH Contamination in Soil

The elevated total recoverable hydrocarbon (TRH) concentrations were identified above the site assessment criteria (SAC) in BH05, located in the central portion of the site.

Area of Concern 2 – Underground Storage Tanks (USTs), Fuel Transfer Lines (FTLs) and Associated Soils

The desktop study identified six (6) abandoned USTs remaining within the site.

Area of Concern 3 - Groundwater

The direction of groundwater within the site was considered to flow in a south easterly direction based on previous investigations. Exceedances of the groundwater SAC (Chromium, Naphthalene and Ethylbenzene) were observed within the most hydraulically up-gradient groundwater well (GWMW-3) at the site. It should be noted that the aforementioned contaminants of concern were not detected above the SAC at GWMW-1 and GWMW-2 which were located down gradient. ADE believed that the removal of areas of concern 1 and 2 would achieve the remediation of the groundwater.

Based on the findings, implementation of the RAP was recommended for the site, detailing the actions required to render the site suitable for its future land use as the extended Warringah Road.

4.4 Integrity Assessment

Historical and site information was sourced from NSW Government departments and reports provided by the client. Jacobs has relied on the accuracy of the documentation provided and our experience in historical document interpretation. Whilst there is a margin for error in interpretation, Jacobs consider the information presented in this assessment to be of acceptable reliability for the purposes of this investigation.



5 Site Information

5.1 Site Inspection

A site inspection was undertaken by a Jacobs Environmental Scientist on 9 March 2018. The site inspection was undertaken from publically accessible areas. Photographs taken during the inspection are provided in **Appendix C**.

At the time of undertaking the site inspection, a significant portion of the site was subject to construction activities associated with the Northern Beaches Hospital and associated road upgrades. Construction activities observed (partially constructed or constructed) included:

- The Northern Beaches Hospital and associated multi-level carpark
- Road and footpath construction adjacent to Warringah Road, Wakehurst Parkway and Frenchs Forest Road
- Pedestrian foot bridges spanning Warringah Road adjacent to the Northern Beaches Hospital and Forest Way.

Remaining areas of the site comprised areas of low density residential development, Forest High School and Frenchs Forest Police Station.

Potential areas of contamination identified during previous investigations including the former brickpit, 7-11 service station and areas of fill on the southern side of Warringah Road between Hilmer Street and Fitzpatrick Avenue were located beneath areas of earthworks associated with the road upgrades or had been removed (i.e. fill on the southern side of Warringah Road) to facilitate road construction.

Existing buildings (e.g. high school, police station and residential houses) located across the site are likely to have been constructed pre-1980. The age of these buildings could indicate that they contain hazardous building materials including, but not limited to asbestos and heavy metals. Whist these building materials remain in a good, non-degraded condition within buildings, they do not represent a contamination issue. These materials (if present) could represent a potential contamination source if they are not adequately managed through ongoing occupation and/or demolition.

5.2 Surrounding Landuse

At the time of undertaking the site inspection, the following land uses were observed surrounding the site:

- North: Low density residential areas
- East: Wakehurst Parkway, bushland, commercial/industrial premises and low density residential areas.
- South: Low density residential areas
- West: Warringah Road, low density residential areas, Frenchs Forest Public School.



6 Discussion

The results of the site history review and the site inspection have indicated that there are a number of potential contamination risk areas on and/or adjacent to the site associated with current and historical activities. These potential contamination risk areas include:

- Former service station site (Esso, 7-11) located at the corner of Warringah Road and Hilmer Street
- Road construction activities (licensed under the POEO Act)
- Other on-site historical commercial land use including paint merchants, nursery, iron mongers, hardware dealers and general engineering (manufacturing and/or mechanical)
- Adjacent (within 500m of the site) historical commercial land use including service stations, rubber moulders, printers, iron mongers, hardware dealers and dry cleaners
- Herbicide application (former POEO licensed activities now revoked or surrendered) within and adjacent to waterways located within 500m of the site
- Former brickworks and infill of the quarry located at the south western corner of Warringah Road and Wakehurst Parkway
- · Former orchard on the Forest High School site
- Filling on the southern side of Warringah Road between Hilmer Street and Fitzpatrick Avenue
- Hazardous buildings materials may be present within buildings/structures present across the site. Whist
 these materials remain in a good, non-degraded condition within buildings, they do not represent a
 contamination issue. These materials (if present) could represent a potential contamination source if
 they are not adequately managed through ongoing occupation and/or demolition of these
 buildings/structures.



7 Preliminary Conceptual Site Model

To assist in assessing potential contamination risks which could impact upon the development of the Frenchs Forest Planned Precinct, Jacobs has developed the following preliminary conceptual site model (CSM) for the site based on the site history review and observations made during the site inspection. The CSM has assessed contamination risks as those risks which could preclude rezoning (e.g. presence of gross and widespread contamination, considerable material investment required to remove, reduce or manage the risk).

8 Conclusions and Recommendations

Jacobs has undertaken the PCSI of the Frenchs Forest Planned Precinct located at Frenchs Forest, NSW.

Based on the desktop information review and site observations, significant contamination that would preclude rezoning is unlikely to be present on the site. The PCSI did identify that the former 7-11 service station may pose a localised source of contamination. Contamination from this site (if present), could be managed through development application (DA) approval mechanisms.

Whilst the PCSI identified the potential for contamination to be present in some areas of the site (namely the former 7-11 service station located on the Corner of Hilmer Street and Warringah Road), the investigation did not identify the potential for gross or widespread contamination which may preclude rezoning of properties within the site. Identified potential impacts are considered representative of common contaminants and potentially contaminating land use activities which can be readily dealt with during the development application stage (i.e. including completion of specific preliminary and detailed site investigations to assess land use suitability consistent with relevant planning instruments) for redevelopment of areas within the site, once later detailed development proposals are made. In the absence of gross or widespread contamination, the requirements of the DUAP/EPA (1998) Managing Land Contamination: Planning Guidelines for rezoning are considered to have been satisfied, namely that the rezoning can proceed, "provided that measures are in place to the ensure that the potential for contamination and the suitability of the land for any proposed use are assessed once detailed proposals are made" (s.4.1.2 DUAP 1998). It is recommended that individual properties within the site proposed to be developed be suitably investigated in accordance with relevant NSW EPA endorsed guidelines to assess site suitability, when detailed development proposals are made. It is also recommended that Hazardous Building Material Surveys (HBMS) be undertaken on sites containing buildings/structures pre dating 1980 prior to any demolition and redevelopment works on these individual land parcels where redevelopment is proposed.



9 Limitations
