My name is David Mason and I am the CEO of the Manly Warringah Football (soccer) Association (MWFA), which organises grassroots football competitions for 20,000 registered players, who are all residents of the Northern Beaches Council LGA.

The Frenchs Forest Place Strategy is an important part of the on-going changes and construction of the Town Centre project but we are incredibly alarmed at the lack of foresight in relation to open space for sports fields.

It looks like Warriewood Valley all over again - despite the Northern Beaches Council Sports Field Strategy identifying the need to include new sports fields when incorporating new housing developments.

This precinct will see an extra 2000 residential apartments/dwellings with no sports fields. It is indeed taking out a sports field (Forest High School) to accomodate this project.

This area is already a high use area for sports with Wakehurst (1645 players), Forest Killarney (1403 players), Beacon Hill (870), Manly Allambie (762) and Belrose Terrey Hills (748) all in and around this area. That is just football teams.

The MWFA, its Member Clubs and 20,000 players would be very interested to see what the plan is to accommodate these new residents and their undoubted desire to play organised sport on weekends.

The technical studies do not include a human health impact assessment. Have the potential health effect associated with relocating the Forest High School adjacent to the zone transmission substation been considered?

The technical study - Frenchs Forest Transport Study was completed in September 2019 prior to opening of the Northern Beaches Hospital Road Upgrade Works. Has the current performance of the road network surrounding the hospital post opening been modelled? As a local resident I note that peak hours access into the Warringah Road slot is difficult. This impacts traffic flow from Frenchs Forest East onto Wakehurts Parkway and Frenchs Forest Road West onto either Forest Way or Wakehurst Parkway.

The Transport study does not include detailed traffic modelling for the potential Beaches Link Project.

The transport study identifies a potential upgrade of the Naree Road/Forest Way intersection. This intersection upgrade was discussed in the previous Northern Beaches Precinct Structure Plan however is not discussed in the current Frenchs Forest Place Strategy. As a local resident I note that access into and out of Frenchs Forest Road west is difficult during peak periods.
