Dear Sir/Madam,

I live at _____ and have been a ratepayer here for more than 30 years. I have seen the pocket of Westmead between Westmead Station, Good Street, Hawkesbury Road, and Amos Street slowing "dying" over these past 30 years as there are not enough people living here. An example of this is the Oakes Street shopping complex of Hawkesbury Road. It currently has 3 vacant shops that cannot be leased as they don't have enough trade as there is currently only residential or low density development allowed in this area.

Another example is across the road from the prime location of Westmead Station. The State Government has approved the multi-billion dollar Light Rail and Metro Rail projects to be built at Westmead station. This is a wonderful initiative by them but currently across the road from these multi-billion dollar projects is a second hand car yard, a vacant block of land that has been vacant for at least 15 years, a rundown single story building that has a doctors surgery and barber shop, a rundown and half vacant Oakes Street shopping centre and a closed down vacant nursery on Hawkesbury Road! These multi-billion dollar projects are less than 10 years and NSW Planning & Council really need to open up this pocket of Westmead for development to be ready for the population growth as people will want to live in this area. I truly believe that if this pocket of Westmead was zoned differently, the light rail would have started from the Great Western Hwy at Westmead and would have come right through Hawkesbury Road with a stop potential half way down then through to Westmead station, then hospital stop and so on. Once the Metro Rail is built by 2030, residents will be able to get the Sydney CBD within 20 minutes. When I saw this Draft Westmead Place Strategy, I thought this is exactly what we need!

I strongly believe that NSW Planning & Cumberland Council need to be ready for this much needed development to bring the

community back to life and take maximum advantage of these State Government transport projects. If not, residents, investors, businesses and developers will take their business to the City of Parramatta Council's north side of Westmead Station. This will be a missed opportunity and lose in potential rates revenues for Cumberland Council. On the City of Parramatta Council's side of Westmead station, I can see that many companies have already commenced building the multi-story tower developments such as the Highline residential towers, the Westmead town centre, Coles Shopping Centre, Retail and Eat Street around the University Campus. From parts of this pocket of Westmead, you can walk into the Parramatta CBD within approximately 15 minutes, walk to Westmead town Centre and Station within approximately 5 minutes, the proposed new Aquatic Centre within 10 Minutes, Parramatta Park within 10 minutes, Bankwest Stadium within 10 minutes, walk to the billion dollar hospital predict, 5 minutes to the light rail and metro rail lines when they are built. This is such a great area with much potential that needs to be developing now, not in 10 years as it will be too late. I believe this Draft Westmead Place Strategy will assist the Cumberland Council into bringing development and life into the southern side of Westmead and really add value to the NSW government investments into the transport and hospital. People want to live in this area and multi storey development should be encouraged in this pocket as outlined in the Draft Westmead place strategy. I know of at least 10 housing commission properties in this pocket Westmead. They on average each housing commission home would be on approximately 1000 square metres of land. They have 1 or 2 residents in each as they are tiny homes but have been built of these huge 1000 plus sq2 metre blocks of land. This is a real waste and shame as these could become affordable homes for many people in need of a house. I am guessing Housing NSW cannot develop these blocks into multi-level apartments as the zoning is R2? If you allow rezoning and make change to the LEP and Development Controls in this pocket, it would allow developers and/or NSW housing to build apartment complexes that have a mix of social, affordable and residential housing. According to the NSW government website there is a 10 year plus wait for social housing in this area with 46,530 people on the waiting list. By considering changes to the development control plans and LEP, this would be possible and thus reduce these waiting times and numbers of people.

Again, I feel that Cumberland Council & NSW Planning Industry and Environment should focus on this pocket of the LGA rather than other parts of the LGA as there is so much opportunity here as I have mentioned earlier. The Draft Westmead Place strategy will assist our community to be ready for the growth and boom of these new transport initiatives, hospital redevelopment, the investment and growth of the Parramatta CBD as well as the billions of dollars being invested by the State Government into South Westmead. Again, Council needs to generate life into this area because of its close proximity to the Parramatta CBD, Westmead station, Parramatta Park, Sydney Smith Park, Westfield's Parramatta, the Western Sydney University, Bankwest Stadium, the proposed ne Aquatic Centre, etc.,etc.

In summary, I would strongly support the proposed Draft Westmead Place Strategy in changing land use activities, zoning, building heights, development controls, Local Environmental planning and density to this pocket of Westmead as it I feel much needed. The only question I have is for the proposed potential "cross block links" that appear on page 53 of the strategy. As I mention, I live at ----- and own -----, I am not exactly sure what this means for me as this potential "cross block links" cuts across both properties in front of Sydney Smith Park. Not sure if it is going to be an expansion of the Park or a pathway coming through my 2 properties? Does this mean that my properties would be purchased by the NSW government or Council if this is approved? The total area of my 2 blocks of land is approximately 2500 square metres, so I am hoping this does not impact of future development here or reduce the potential development land value of my homes. That would be really concerning for me and my family and for my neighbours who would also be impacted. I would like this explored and/or clarified further, so I can better understand what this means for me and make an informed decision. If you can provide me with more details on this, that would be much appreciated and happy to discuss section of the Draft Place Strategy further.

We would like to express our opposition to the proposed replacement of current dwellings in Balfour St Northmead with new affordable housing - increasing the local population and negatively impacting the character of our area.

Balfour is a very quiet little street, occupied in the main by long-time local families. This is where we have chosen to live. We like it here.

We are one of many local families who have invested in the area here - building a new family residence in which to raise our children. A quick walk down Balfour St will show 5 very new homes amid the well-kept traditional bungalows of Northmead, many of which have been renovated and restored.

Balfour St also sits beside the Toongabbie and Darling Mills Creeks and what little bushland remains in their surrounds. Again, the feeling and character of the area will be negatively threatened by introducing higher density affordable housing on the doorstep to the Parramatta River.

The local streets here also cannot adequately handle any further increases in traffic - which will no doubt come with the introduction of more residents. Local streets are increasingly busy with traffic after recent developments in the area. Getting on and off Briens Rd at the Kleins and Redbank Rd intersections is very problematic at busier times of the day. Further stress should not be added to these intersections.

We would like to see the current character of Balfour St maintained, with single dwelling units suitable for families like us. We are opposed to the introduction of affordable housing in our street as well as those surrounding.

DRAFT WESTMEAD STRATEGY RESPONSE

The Westmead 2036 Draft Strategy is an insightful and ambitious plan with many great qualities though I believe that there are some significant omissions that are summarised below. These concerns below are views from a resident of over 30 years who has seen the area change dramatically.

Covid Considerations

- Draft Westmead strategy does not take into account COVID like events where open spaces were oversubscribed. With the SIGNIFICANT increase in medium density housing in Westmead particularly around the Great Western Highway there has been NO increase in open public spaces at all.
- No consideration to new open spaces directed at youths such as cricket nets and half basketball courts. On any good weather evening there are more than 25 kids roaming the end of Oakes St near Pemulway Reserve Park where there is a small playground that caters for children 1-6, we need to provide facilities for older children. With the demographics of the population being primarily Indian or Sri Lankan then Cricket nets or cricket pitch make a lot of sense.

Indigenous Fauna

- There is no mention of protecting local fauna? An example is the prevalence of Indian Myna birds that are destroying native bird species and driving them out. How do we introduce more native fauna back in their original habitat?

Climate Change

- Climate change is the most pressing issue particularly for millennials in today's society and yet it is given little priority ?
- Why is the increase of trees on streets and in greening of medium density dwellings not a priority when the land surface temperature is increasing?
- Why aren't new developments following the lead of the Central Park in Broadway with extensive greenery on the building, even mandating roof top community based gardens which is aesthetically pleasing and beneficial to reducing land surface temperature.

Aesthetics and Environmental Concerns

- When looking at areas with medium density there is a problem with rubbish continually piling up in front of units and shopping trolleys littering the streets(Good St) that the council has not addressed.
- There is no mention of beautifying the area by removing telegraph poles and power lines and replacing them with trees? All new major developments should be mandated to incorporate the removal of overhead power lines.

Cycling

- The draft talks about door to door access for safe cycling but is scant on any real details or even a direction about providing greater bike racks and motorbike parking at major sites. It seems to be relying on Transport NSW rather than taking the initiative themselves.
- If Westmead is going to be a health and education precinct then it will be accessed by a large number of low to middle income youth who rely on bicycles as their major form of transport, more dedicated bike paths need to be established to all the surrounding satellite areas not just a single path as is the case now.

Growth

- There is the common misconception by economists that growth is needed to improve our living standards, Japan is a prime example of a nation that has not increased in population, or GDP and Japan is in the top 20 in the quality of life index. By not increasing our population also benefits climate change.

I am concerned that most of the existing open space will be built out, and the heights of buildings and overall density of the development is not specified.

The plan's purposes include identifying "opportunities for increased open space" (page 7). The plans for this area are inconsistent with this purpose. It is not satisfactory to say that open space may be created elsewhere. Once gone, it will never return.

The language of this purpose is purely aspirational; quite possibly, no opportunities for more open space will be identified at all, or, at best, amount to trivial pocket parks which are no substitute for large open spaces.

The previous plans by Urban Growth, since withdrawn, represented over-development, and included some very tall residential towers incompatible with the heritage values of the area.

There is no information in the document to reassure stakeholders that this plan is any better in that regard.

The community deserves much more specific detail on these proposals and the opportunity for further submissions before any claim can be made that the development has community approval.

I would like to draw an attention of planners and/or decision makers that there is a pedestrian/service vehicle subway (railway line underpass) at Park Parade, which links the area between existing Parramatta Golf Course and Parramatta Park (Westmead side end). This underpass is very heavily used by the local and other residents on day to day basis to access Parramatta park for recreational/exercise purpose. This access is even more important when special community and other events are happening in the parramatta park including Bank West stadium and surrounding areas. However, there is no provision for traffic light or humped zebra crossing at Park Parade for pedestrians/bike riders. Comments on Westmead 2036 – Draft Place Strategy

Transport The Strategy includes reduced car dependency in favour of train, light rail, bus, cycling, walking and refers to a future traffic study. With only 2 roads serving the Health & Innovation precinct, traffic movement is a key issue. With many thousands of people working and learning in this relatively small area and moving to and from every day, proposals for new roads, road widening and/or road tunnelling should come first in the planning.

Direction 1 refers to “improve road network” but seems more concerned with aesthetics than efficient motor vehicle movement.

Concerning “Westmead South”

Housing There are numerous references to “student accommodation, key worker, social and affordable housing”. What about existing residents, retirees and those who live in Westmead but don’t work there? There seems to be no acknowledgement that this group needs to be considered.

The Strategy places emphasis on “tall, slender building envelopes rather than short squat massing”. We currently see ugly tall, squat massing along the Mays Hill – Westmead – Wentworthville section of The Great Western Highway. The Town Planners’ carefully selected wording doesn’t change the preference of most people for individual houses.

Direction 8 Actions There are references to “site amalgamation”, “housing intensification”, “housing diversification” but listed actions are all short term and relate to studying these objectives. When will we know how these objectives are to be implemented and will these later plans be open for community consultation?

I am a doctor living and working in Westmead. I am in support of the measures as outlined in the draft strategy. I would like to expand on several points outlined in the document.

- More options for cycling and walking. This includes ensuring there is adequate secure bike parking at key locations, e.g. shops, transport hubs, etc.
- In regards to liveability, strategies need to be implemented to promote a cooler urban environment. I believe this is one of the most pressing issues to face Western Sydney today. Western Sydney is routinely 10 degrees hotter in Summer than Eastern Sydney and there are days residents struggle to live/work in this environment. There needs to be more research, innovation and planning in order for Westmead to remain liveable in the near future. This should include adequate shade and nature strips by the pavements to encourage a cooler urban environment that has the capability to absorb and release water. I was quite disheartened to see a nature strip with older trees replaced by a concrete strip on Jessie Rd in 2019. Concrete tends to absorb heat. Green space is vital to cool the area. In addition, the waterways may be cleaned up to promote recreational use on hot days
- There needs to be mixed density of housing to avoid over development. Westmead East is already saturated with high density housing and there is traffic congestion in addition to difficulties with street parking already.
- I would like to see grocery stores and other essential services located along the transport hubs/walking and cycling routes to reduce the need for residents to use cars. E.g. current major supermarket is Coles, which is only reachable by most people via car
- I support the improved links between Westmead and other major urban centres, e.g. Castle Hill, Western Sydney Aerotropolis, etc. In particular, I strongly believe linking up Westmead Metro to the Aerotropolis/other Metro lines will future proof the Parramatta region in the face of future population growth, infrastructure development, social changes, etc. It will also cement Parramatta as an

important centre for business/pleasure as well as a desirable place to live

- I support the promotion of a historical/social/cultural scene. Western Sydney is unfortunately somewhat culturally barren. Not for want of diversity and cultural assets but for lack of funding, coordination and promotion. Again this would encourage many Sydney residents to view Parramatta as a place to live/visit/work.

- I support the linking up of existing/new walking/cycling paths. For example, the Redbank trail is a lovely underutilised little trail. I believe it should be expanded (in length and width as it is too narrow to allow cyclists and walkers at some parts) and promoted. At the same time I would like to see the little nature in the neighbourhood preserved to minimise the ecological disturbance to the area

- With all the focus on attracting workers and students, I would like to see that Westmead will also have child friendly facilities

I provide this submission in response to the Planning Strategy for Westmead.

I am a current resident of Westmead, who grew up in the area and have seen considerable changes to the suburb over the decades.

The draft strategy causes me considerable concern. As a person with disability, I'm all too aware of the considerable and numerous barriers to pedestrian access to the health and education precincts within Westmead and yet the word "disability" is used once in the definition of terms throughout the strategy. Westmead must become an area where people with disability can navigate their way around with ease. That necessity is because people with disability are part of and live in the broader community but also because the health precinct also brings many people with disability into the area. Footpaths, crossings, accessible seating, level and open spaces must be made available as a priority. Constant building works cannot be an excuse for never providing an environment in which people with disability can move around safely and freely.

Further, in regards to pedestrian access and movement, I highlight three areas in Westmead that require immediate and considerable improvement.

One is Ashley Lane, Westmead. Ashley Lane is an area used by many people accessing the hospital precinct, yet has no usable pedestrian pathway for most of the lane and is frequently blocked by vehicle entering and exiting parking areas. That is a danger to pedestrians and should be addressed immediately.

The second area that requires considerable improvement is the walking track around Parramatta Park. When I say "walking track" I am of course referring to the road for cars, with a marked section for bikes. A path that is wide enough for one person only, walking in a single direction without company is dangerous more often than not as cars drive in the lane, bike riders often sway into the walking lane or people feel the need to walk with company - an activity that is not supported by the current single lane. If you are serious about pedestrian access to the area and the enjoyment of the recreation facilities available, whomever is the responsible party for Parramatta Park will act to improve the walking space of all.

The third area that requires considerable improvement is the pedestrian underpass from the railway in Parramatta Park proper. As has been the case for many years, clouds only need to hover over the entrance or exit of the pedestrian tunnel and a large collection of water is gathered. Despite repeated requests to Cumberland (previously Holroyd) and Parramatta Councils, the Roads and Traffic Authority and Transport NSW to install some form of drainage and/or better connection points, pedestrians continue to navigate through waters and mud on a regular basis to gain access to the tunnel. Again, if you wish to be taken seriously in your desire to improve the Westmead area, you will at least address these three long standing issues that have been previously brought to the attention of all the relevant responsible authorities.

As a resident of Westmead, and of Alexandra Avenue for over 40 years, I would like to provide you with my submission. I care deeply for this suburb, and have seen so many positive developments and changes, with the section of Alexandra Avenue between Hawkesbury Road and Bridge road completely overlooked until now.

The section of Alexandra Avenue between Hawkesbury Road and Bridge road is a vital corridor between the west and east centres, and the current homes in this section are now under the shadow of massive unit developments opposite the street and railway line.

These imposing 21 storey unit developments straight opposite the single storey homes in this section of Alexandra Avenue combined with the proximity to the station, the new metro, and hospital district make it no longer a tranquil or reasonably comfortable location for single storey family homes. Due to the developments and plans, and traffic, it simply lost the atmosphere of a neighbourhood feel, and now feels like we are in the way of the hustle and bustle that this vital transit corridor has become.

As such, I would like to put forward the notion that this section of Alexandra Avenue between Hawkesbury Road and Bridge road is now only viable for medium to high density dwelling, with commercial/retail use on the ground floor, to keep in alignment to the Units opposite the railway, and in keeping with the surrounding Westmead station, T Lane Station, Light rail, and Metro, a few hundred metres from this section. This will allow the hundreds of commuters disembarking at Westmead and walking through this

section of Alexandra Avenue between Hawkesbury Road and Bridge road every weekday morning and night, to have a safe and welcoming vibrant and functional corridor as they may their way to work or home. This is what this section now suited and overdue.

I hope this submission provides you the opportunity to visit this section in person to understand the importance of seamlessly connecting the station and metro surrounds to this section of Alexandra Avenue between Hawkesbury Road and Bridge road.

A Universally Adaptable Parking Trolley Service for Sustainable Sydney

Purpose

To reduce driving and parking pressures in parks and shopping towns by families while they visit such places for picnicking, sporting, shopping and other purposes. [The timing of this concept has been galvanised by the recent announcement of car-free parks by the NSW Minister Hon Rob Stokes.]

Rationale

The NSW Government has been working on a sustainable city. Since most members of the families in Sydney use their family vehicles for travelling to-and-from nearby shopping centres and recreational parks in Sydney, a lesser extent of driving can ease pressure on carbon emissions. At the same time, this can allow a healthier and safer Sydney for everybody, by avoiding driving at shorter trips and increasing demand on public transport.

Families usually carry quite a few picnicking, sporting and shopping gear while they visit a park or a shopping area. The present logistics in carrying such items to-and-from any park in Sydney by using any public transport; whether visited for picnicking and/or sporting purposes, is extremely discouraging, if not impossible. If one is desperate to take public transport for this purpose, one will have to pack items, carry to the nearest public transport mode by a private vehicle, face all other hurdles in the public transport system (including public dislikes for carrying baggage items) and then face the same issues to reach a picnic or sporting spot. And, the same is repeated on the return trip. Exactly the same happens while on a short trip to-and from- shopping towns. Therefore, unless, other convenient and sensible options are available, due to a lack of logistics and convenience, families chose the easier option - driving. This is unsustainable and insensible.

The Concept

This concept of universal and adaptable parking trolley is very simple: just to introduce a new trolley system that can be easily used by families, starting from the family home to the destination park or shopping town and then back home; with the use of public transport as the intermediary carrier. On the way, one should be able to pick-drop-change Trolleys if they like. This will require making a minor adjustment to the existing transport system in major cities. It will also need the public to slowly but surely get used to this new but sustainable approach. It may be eventually managed by a private entrepreneur but it will require initial patronage by the public sector as a pilot.

Essential elements of the Concept

The essential elements of the concept are listed below (see attached conceptual drawings):

- Trolley and Basket are two components of this concept. Up to eight Baskets may be packed in one Trolley.
- Trolley or Basket that can be used in train, bus, ferry, light rail and other public transport modes. The service should be initially a State owned but gradually privatised service, however, is availed by its patrons on a payment basis.

- Those transport services to have compatible Basket Slot in the transport itself as well as Trolley Stations at the main transport nodes (railway stations, bus terminals, ferry terminals, other stations).
- Trolley Stands are particularly necessary at the Park and shopping ends of the journey, so that Baskets can be stacked on Trolleys and trolley-away to picnic destinations within the Park or the shopping centre.
- The Trolleys will have to have an initial security deposit plus be rented from a Trolley Station on a paying basis and easily linked to the Opal Card system.
- On return to any Trolley Station (also serving as a Basket Station) within the network, the Opal Card will register the return but a failed return Trolley or Basket will incur a longer rental fee chargeable to the same Opal account.
- The Trolley will have specific slots to take modular Baskets. If one wishes, may only use just an individual Basket and not needing to use a Trolley, or stack up to eight Baskets in one Trolley.
- Baskets will be fully compatible with those Trolleys and also be part of the same Trolley Service. However, a family may like to rent or pre-purchased Baskets and return (if wish) but only rent a Trolley.
- Baskets will also come with wheels so that if a family wishes to carry only a Basket filled with picnicking and sporting gears to a park, or shopping items they can do so.

Design, Logistic and Operational Requirements

The detail design and structure of the Trolley and Basket will need further thoughts and works. However, as a preliminary concept the below figure shows some essential components. Basic features are as below:

- Trolley will be made of durable recycled plastic components, with metal parts where needed.
- Basket will be primarily made of recycled plastic and tough fibre so that those also help the environmental sustainability concept but most importantly, lighter and tougher. Perhaps something like Milk Crates or baskets in shopping centres.
- Trolley will have tough wheels so that those are long-lasting (tough, weather-proof) and weight bearing. A Trolley should be able to carry up to 160kg of total weight out of eight Baskets. The rear wheels should have foot-locker option or something like airport trolley's, which have idle-state brakes.
- Each Trolley will have slots for holding four Baskets (two on the sides and two at the front and then stacked on top). As the Baskets are placed in the Trolley, those should be self-locked but then easily unlocked by simply lifting a lever. The purpose of locking is to secure the items while in transport. The dimension of the Trolley could be 1,090mm long, 690mm wide and 690mm high, with the handle of standard height.
- Each Trolley will have a strong and foldable handle for trolleying away or something like airport trolleys.
- Baskets will be also similarly tough so that each can carry a fully filled small Gas Cylinder (approximately 10kg), soccer ball, footy ball, most picnic gear; however, a maximum total capacity to carry 20kg. Large items as cricket bat, tennis racket, surf boards will have to be packed separately. Therefore, the dimension of a Basket should be approximately 520mm long, 320mm wide and 320mm high (size of a standard fruit box).
- Each Basket will be modular so that those can be stacked one on top of the other and sideways (similar to Milk Crates). Each Basket will have to have self-locking lids so that items do not escape and stay inside the Basket. The lock should be easily opened by the user by simple moving of a lever. Each Basket will have its own collapsible handle for trolleying away. Baskets will also have to have foot-locker option, such as those on baby stroller.
- Each Trolley and Basket will have its unique serial number and an electronic chip so that when returned to a Trolley Station, it will be identified by a scanner fitted to the trolley aisle. As it is scanned, it will be

communicating with Opal Card system. A security deposit will apply and also a rental fee for the Trolley and Basket. This will encourage their returns.

- Damaged and/or lost Trolley or Basket will incur a penalty.
- The Trolley and Basket Stations at transport nodes will have to have plenty of Trolley and Baskets for patrons to hire. Those will only need a Station, with scanner and appropriate pathway network to trolley between. Plus, a covered space to protect Trolley and Basket from catching dust and dirt.
- Trolley Stations will be only at the beginning and end of the journey (not on the transports). Transports will only carry Baskets. One may use a Trolley from a Trolley Station to transport one or more Baskets to their place/s but then return the Trolley to any Station. One may wish to rent the Trolley but one may Rent or pre-purchase Baskets. Similarly, at the node of the public transport at the Park end or shopping, one may choose to hire a Trolley to carry one or more Baskets. And similarly, return the Trolley (and may be Basket) at the Trolley Station before catching the public transport.
- Picnic spots and shopping centres will have to be directly connected to the nearest public transport node/s by suitably trafficable pathways so that Baskets and Trolleys can be trolleyed away easily and safely.
- Public transports will have to have designated Basket Slots (not for Trolley) inside the transports so that they can accommodate Baskets (only Baskets, not Trolleys). It could be also plausible that some passenger seats nearer to the doors are un-folded so that when a Basket need be stored, the seat can be folded and Baskets get priority over passengers in those Slots.
- Cabs and other private services should be also familiar with Trolley and Basket services, however, they may only accommodate a Basket in their boots. Boots might have slots for Baskets but this is not essential.
- One may use the Trolley or Basket for shopping at shopping centres and then further use it to carry items to home; then return. Shopping Centres should be encouraged to allow such Trolley or Basket to be used in their stores.
- Trolley or Basket will unlikely to create a pest-impact and hazard as those created by (for example) eBikes, because this system will be a favoured option by the public. Also, since there is a security deposit involved, one is unlikely to not look after it and not return.

Implementation

To begin with, the concept can be only implemented by the government sector; as multiple agencies will have to be involved in making it to work. It requires the transport department, public space and recreation department, environment and planning department, local government, public businesses such as cab and Uber services, and the public at large. It may require passing some new legislation and other guidelines. The public sector will need to lead the logistical part of it, however, the actual operational aspect may be leased out to a private operator.
