Description of the development consent

The Concept Plan (MP 06_0318) was approved on 19 August 2010 by the then Minister for Planning for various land uses including a town centre and neighbourhood centre, residential, employment, community and education, recreational, wildlife corridors, protected environmentally sensitive areas, water management areas and associated infrastructure.

Description of proposed modification

The modification request seeks to amend the Kings Forest Development Code (Code) to:

- allow for variations of the Code without need for modification of the Concept Plan;
- allow additional land uses in the Precinct Development Matrix at Figure 1.2.2;
- update the glossary to reflect Standard Instrument definitions;
- clarify the status of various planning controls; and
- correct errors in Table 5.4.1 'Minimum Area and Dimension Controls for New Lots'
