## Description of the development consent

Concept approval (MP 06\_0258) for a subdivision comprising low and medium density residential, retail, commercial and mixed use lots, a retail centre, a hotel and associated road network, landscaping and open space. The original concept approval has been modified on eleven previous occasions.

# Description of proposed modification

The request seeks to change the approved use of the building from mixed use medium density residential to mixed use to facilitate specialist medical services and to increase the approved building height from three storeys to three storeys with a partial fourth storey for a rooftop terrace.
