As part of the RFI response, DPIE have requested we provide evidence of Council's in principle support for conveying stormwater beneath the building as shown indicatively on the attached. Key items to note;

- Stormwater will be conveyed beneath the building with Council having the benefit of an easement over the new pipe. Vertical clearance height as shown in the attached sketch to be provided for any future maintenance.


