

However, I am conscious of the financial returns the development would deliver to the Metro LALC, so hereby offer an alternative means of delivering a long-term return to the organisation.

Potentially, this would require using up to around 20 acres of the designated land area, that closest to an existing population area, specifically for a three level bilingual education facility.

The multi-stage schooling would focus on biodiversity, forestry maintenance, and agriculture, for both day and boarder students.

The initial facility would involve an early-learning centre for the immediate district and indigenous families who could access the centre. It would be English and an (appropriate/available/useful) indigenous language/dialect. (Acknowledgement: I have previously consulted to a Singapore-based Asia-wide chain of multi-lingual early learning centres.)

Students would then graduate to a Primary level and later Secondary level schools, again bilingual, and focused on Agricultural and Forestry/Rehabilitation streams, and open to local entrants plus boarders from around Australia. In particular, aboriginal student boarding would be encouraged.

A long-term successful model for this approach exists on the NSW Central Coast, at Kariong. The private Secondary school facility, NAISDA, the National Aboriginal and Islander Dance school has been fundamental in graduating hundreds of indigenous dancers, actors and theatre workers for the arts industry.

## Comments on the development proposal for Patyegarang or Lizard Rock, Morgan Road, Belrose

## Dear Sir or Madam,

I am a lifelong resident of the Northern Beaches and I urge you in the strongest possible terms to reject the proposed rezoning of land at Patyegarang, Morgan Rd, Belrose – formerly known as "Lizard Rock" (PP- 2022-3802). This proposal contravenes many principles and policies espoused for the protection of the natural environment and best-practice planning. It would be ludicrous for the government to approve such a shocking development which is vigorously opposed by the Northern Beaches Council and by the local community.

It should be refused for the following reasons:

## 1. Loss of habitat

Bushland remaining within the urban and suburban areas needs to be treasured and protected, not bulldozed. Again and again, we are told by researchers of the vital importance of wildlife corridors to native fauna to survive. As the site proposed for development has never been cleared, the original native vegetation offers habitat which connects private land and public land preserved as Garigal National Park or Narrabeen Lagoon State Park. The only appropriate rezoning would be to give it the protection it deserves by acquiring it to add to Garigal National Park or Narrabeen Lagoon State Park. It is such a joy to still see swamp wallabies and other wildlife in this area. They cannot survive continued habitat removal.

## 2. Impacts on Narrabeen Lagoon Catchment

Inevitably, the development of bushland will result in a great increase in the volume of stormwater flowing down to Narrabeen Lagoon, with sediment and pollutants. Greater stormwater will add to the flooding problems of the Wakehurst Parkway, which the government is planning to spend a large amount of money trying to mitigate. How ironic if another government body approves increasing the problem.

## 3. Reduction in the many benefits of green areas within urban areas

Having trees and other vegetation significantly cool urban areas, increasingly important with climate change creating more extreme heat. Both the previous and current governments support extensive tree planting for this reason. The role of trees in absorbing carbon is also ever-more important.

4. Contravening Council's strategic planning and opening the door for other developments Northern Beaches Council has given an extremely thorough and damning analysis of the proposal. The Lizard Rock proposal contravenes the strategic planning of Northern Beaches Council and makes a mockery of their attempts to balance housing needs with protection of the natural environment.

There is considerable land in the Oxford Falls and Belrose area classified as the Metropolitan Rural Area, a precious asset in an area which is becoming very developed. Council is undertaking a strategic review of land use within this area and is proposing to zone private land as Rural and C3 Environmental Management zoning. If the Lizard Rock proposal was approved, it also opens the door to rampant development of a much broader area.

## 5. Bushfire Risk

Each time there is an inquiry into bushfires, it is recommended that further building be restricted in areas of high bushfire risk. Why would you approve a major development of 450 houses in aeras of Very High – Extreme risk with limited evacuation routes? The extra population would certainly add to the probability of traffic jams on Forest Way in the event of bushfire, putting many people at risk. The level of clearing required for Asset Protection Zones has increased a lot over the last decades as evident in the 10/50 legislation which has led to the loss of so many trees in the Northern Beaches. With climate change, the area recommended for APZs will only increase. This development will require fairly complete removal of the bushland with token trees left.

## 6. The role of the Metropolitan Local Aboriginal Land Council

With great dismay, I have seen the sale for development of three other areas of bushland claimed by the MLALC despite the objections of conservationists each time. The first was along Mona Vale Rd a long time ago, maybe 20 years. Then there was a very significant site at Duffys Forest which contained the largest area of Duffys Forest Endangered Ecological Community left in the WORLD! Yet, the MLALC were allowed to sell this site for development.

There was also a site at Bantry Bay, overlooking Middle Harbour.

I understand this Land Council owns six more bushland sites in the Northern Beaches and may well want to sell or develop these too.

I have been told that there have been unsuccessful attempts to negotiate with CEO Nathan Moran and arrange land swaps with land that is more suitable for development.

Many of the dedicated environmentalists who have given enormous voluntary time across their lifetimes to preserving the local environment through bush regeneration, advocating for appropriate planning and objecting to overdevelopment shake their heads in disbelief that they are now having to fight an Aboriginal Land Council that is so intent on destroying bushland for profit. Many of these same people have recently been enthusiastic volunteers for the Yes vote in the referendum and support local reconciliation initiatives. The MLALC's proposals for development involving the destruction of bushland seems so contrary to all that we continually hear about connection to country and caring for country. Surely, it is no better to have native plants and wildlife destroyed by an Aboriginal group than by a developer of any other background?

The previous government introduced a SEPP enabling streamlined approval for development proposals from Aboriginal Land Councils. If preferential treatment is given to this proposal because it is from an Aboriginal Land Council, this will lead to a most unfortunate community backlash. This would be a real set back to the movement for recognition and reconciliation at a time when we so need to build goodwill and connection.

I have not seen any explanation of where the money has gone from the previous sales and how will the money from this development be allocated? To whom, by what criteria, how much? What are the governance procedures regulating the management of such large sums? I understand that members of the MLALC do not need to show any connection through their heritage to the sites they claim and they may come from other places in NSW. Local Aboriginal people on the Northern Beaches oppose this development and are not part of the MLALC. The basis for claiming Crown Land with intact bushland in order to development needs urgent review. Otherwise there will be more and more conflicts such as surrounds Lizard Rock.

We need to provide balanced avenues for genuinely disadvantaged indigenous groups to achieve economic viability. But not by sacrificing remaining native bushland and its precariously surviving wildlife.

Please reject this destructive proposal and find a better way.
