The planning proposal has significant planning, environmental and hazard issues, including bushfire risks, enormous loss of high biodiversity habitat, inconsistency with planning strategies and inconsistency with Council's 'Patyegarang Planning Proposal'

I strongly oppose the clearing of 126 acres of bushland and build 450 dwellings full of following reasons:

The Biodiversity Development Assessment Report doesn't list the known inhabitant wombat or the endangered Angus Onion Orchid, Microtis angusi found by residents on the site. The report is aware koalas, listed as endangered, and the Heath Monitor, also known as Rosenberg's Goanna, Varanus rosenbergi, currently listed as vulnerable in New South Wales, have been seen here.

The amount of 'offsets' required to raze this land and kill all the wildlife thereby that lives in and on it, such as the Eastern pygmy Possum, amounts to thousands of required 'credits to be retired'. The BAM Biodiversity Credit Report (Like for like) lists Pittwater, Cumberland, Sydney Cataract, Wyong and Yengo or any IBRA subregion that is within 100 kilometres of the outer edge of the impacted site[Interim Biogeographic Regionalisation for Australia].

However, in missing the endangered Angus's Onion Orchids that grow here, that occurs on soils in the restricted ridgetop lateritic soils in the Duffys Forest - Terrey Hills - Ingleside and Belrose areas - the 'like for like' may be difficult. These soils support a specific and distinct vegetation type, the Duffys Forest Vegetation Community, which is listed as an endangered ecological community under the TSC Act and ranges from open forest to low open forest and woodland; intact Heath, intact Woodland and intact Forest..

Cr Kristyn Glanville, Northern Beaches Councillor and member of the Northern Beaches Bushland Guardians campaign has stated that the State Government is continuing to progress a planning proposal where independent bushfire assessment shows that building houses in places where lives will be at risk. The lives of the residents and the lives of our local RFS volunteers".

"This rezoning proposal being approved will trigger a precedent across the Northern Beaches and NSW. Close to home, it will set the precedent in the deferred lands that any owner on high quality bushland can get a spot rezoning to residential zoning. Across NSW this SEPP opens the door for mass clearing of native vegetation, despite the 30 by 30 targets to conserve 30% of nature in NSW by 2030.

"Its astounding that the State Government is considering an ordinary residential zoning, as future dwellings could rely on private certifiers to obtain CDCs. The land at Lizard Rock is more appropriately zoned C3 Environmental Management, as this would rule out development via CDC in such a environmentally sensitive and bushfire prone area.

The Northern Beaches Bushland Guardians campaign does also want to see a fair outcome for MLALC. The State Government has given them land as compensation from which they cannot earn any income, but which is fundamentally unsuited for development. We are pushing for an alternative such as a land swap for developable land without environmental value, or leasing Lizard Rock from them as a National Park. The land was given to MLALC as compensation for past wrongs, but clearing the bushland there would be committing new wrongs against nature."

Envirolink President Dr Conny Harris stated "It is integral that we protect every piece of remaining intact biodiversity to address climate change and stop the extinction crisis. "As a local GP, I see that we are in a mental health crisis. Not only is saving the bushland good for the environment, but places to bushwalk and meditate are also critically important for our mental well being and physical health".

Koala Spotted In Belrose Area

Unfortunately, this crucial information is not made explicit in the proposal and should not be ignored by the community and decision-makers. In fact, the local community and community groups made 1,132 submissions objecting to this DDP.

Today, as Australians budget billions on solar, home battery and electric vehicles, as we redesign our diet, as investors (including most of us with a superannuation account) compromise on returns to decarbonise, and as we debate what more we must give up to break free from our carbon ties, cutting down 51.1 hectares of natural bush by the Ku-ring-gai National Park in the 21st century, in one of the wealthiest lands in the world to accommodate a 20th century lifestyle just doesn't make sense.

I write on behalf of those who cannot write a submission for themselves – the wildlife that live at Lizard Rock, and the future generations who have a right to a healthy natural environment.

I believe that the Department has not acted impartially in relation to this developer. The MLALC are just a developer like any other developer, and they should not be supported in the way the Department is supporting them. On 22 February 2022 at the public information session, the Department's representative admitted that:

Planning Proposal No. PP-2022-3802 Patyegarang, Morgan Road, Belrose

Dear Sirs,

I wish to register my objection to the planning proposal (No. PP-2022-3802) to permit the rezoning of approximately 72 hectares of bushland surrounding Morgan Road at Belrose for proposed residential development.

My primary concerns, and the basis of my objection, are as follows.

- Destruction of bushland, and consequent loss of habitat and biodiversity. The subject area is a reasonably intact, high quality, compact shaped, and very valuable area of urban bushland. The proposed concept plan sees most of this area developed for residential purposes or as managed (i.e. cleared/manicured) open space with only residual areas flagged as possible conservation zones or narrow bands of retained vegetation along drainage lines (which are ineffectual, and unsustainable in the long term, as native vegetation retention and habitat areas). With nearly two-thirds of the site to be cleared (around 45 hectares or 62.5%) this will have significant, and in my view unacceptable, environmental impacts and represent a loss of vegetation, habitat, and biodiversity that is significant at an LGA/regional scale. The subject area's environmental value is recognised by its recommendation as a "C3 Environmental Management Zone" for much of the site in Council's recent conservation zones reform project.
- Exposure to unacceptably high bushfire risks. The future residents, and built assets, of any residential development in this area would be exposed to an extreme and unacceptable bushfire risk. The proposed evacuation route west along Morgan Road is impractical and also high risk, due to the "run of fire" typically being west to east which would see residents being asked to drive towards an approaching fire front (which many may be very reluctant to do) as well as the winding and uphill nature of this road (making it more challenging to use under smoky conditions by possibly panicked drivers). The proposed residential development of the Ingleside area was rejected on the grounds of unacceptable bushfire risks, and in my view the Patyegarang Planning Proposal would present an even more hazardous bushfire situation.
- Inconsistency with higher order planning strategies/documents. The planning proposal
 is inconsistent with, and in many aspects not supported by, the planning directions
 contained in the State Government's and Northern Beaches Council's higher order
 plans and strategies notably the Greater Sydney North District Plan, Towards 2040 Northern Beaches Local Strategic Planning Statement, and the adopted Northern
 Beaches Local Housing Strategy.

• Additional infrastructure demands. Around 450 new dwellings will place further stress on the surrounding, and wider, area's urban infrastructure (notably the arterial road network and peak hour traffic volumes – the proposal's Transport Assessment, September 2023 provides a very cursory assessment in this regard). The Northern Beaches LGA as a whole has only 14 lanes of traffic – 7 lanes in and 7 lanes out (at the Spit and Roseville Bridges and on Mona Vale Road) – connecting it with the rest of Sydney. A fact that developers and governments seem to overlook when promoting ever more, and ever denser, urban development in this area.

If the government is committed to the objectives of the *Aboriginal Land Rights Act 1983* a more desirable, and on-going long-term, beneficial outcome from an economic and social justice perspective for the MLALC and it members (as well as preferable from an environmental and land use viewpoint) would be a long-term lease of the subject site from the MLALC for possible addition to either of the nearby national parks (Ku-ring-gai Chase NP or Garigal NP) or to the Narrabeen Lagoon State Park.

Overall I feel the current proposal should be rejected on the basis of its significant planning, environmental and hazard issues and their numerous foreseeable unacceptable consequences.

Patyegarang Planning Proposal PP-2022-3802

Summary

As the Federal Member for the Electorate of Mackellar I wholeheartedly support the intent of the Aboriginal Land Rights Act, but I cannot condone the Patyegarang Planning Proposal PP-2022-3802 - because of the extreme risks and adverse impacts this particular proposal presents for the community of Mackellar.

I note that the Patyegarang Planning Proposal PP-2022-3802 (Lizard Rock rezoning) is also strongly opposed by the local Northern Beaches Council and all the MPs of the relevant state electorates that are practically and geographically impacted by the proposal, including the Member for Wakehurst, the Member for Davidson, and the Member for Pittwater. There is also strong community opposition to this development proposal and there was minimal community involvement in the development of the plan.

The reason I oppose the proposal is because it goes against good planning principles and is inconsistent with key aspects of existing planning and affordable housing policies and strategies that apply to the area. It was not created with the community's needs in mind. The Northern Beaches Council's well thought-through plan for affordable housing, in contrast, was created in close consultation with the local community.

The main concern is that the Patyegarang Planning Proposal poses an unacceptable bushfire risk. In addition, because of the limited infrastructure in the vicinity it would condemn future residents to a car-dependent lifestyle, increase local traffic congestion, and exacerbate problems of access to services.

The proposal is environmentally devastating and would lead to the destruction of important pieces of bushland equivalent to 46 football fields and further loss of important local ecological habitats. It will also undermine efforts to provide green lungs for our city to ameliorate the impact of climate change.

Inconsistent with planning policies

The proposal does not demonstrate strategic merit and is inconsistent with key aspects of the Greater Sydney Region Plan, North District Plan, Northern Beaches Local Strategic Planning Statement – Towards 2040, and Northern Beaches Local Housing Strategy.

The Patyegarang development proposal is a plan for low density housing and as such will not meet the diverse range of housing needs of our community either now or into the future. It is inconsistent with the council's plan to develop a diverse range of <u>affordable and sustainable housing</u> on the Northern Beaches of Sydney.

Northern Beaches Council spent many months consulting with our community about the local housing needs and their strategy to address this and takes into account access to public transport and walkability. Walkability is known to be one of the key factors affecting people's satisfaction with where they live and is essential to sustainability principles of planning.

A far more sensible approach is outlined in The Northern Beaches Council's comprehensive housing plan which aims to develop medium density, walkable neighbourhoods and increase the diversity homes available, including a higher proportion of affordable homes in strategic locations. A diverse range of housing is required to meet the needs of people of all stages of life – not just more low density housing. This is what the community wants , and this is the most sustainable, and fair way to tackle our housing crisis.

Fire risk

The proposed development for 450 homes at Lizard Rock represents an unacceptable fire risk to the community.

Building properties in fire prone areas puts not only the lives of future home owners and their families at risk, but also increases the risk to our many volunteers and professionals in local fire services, who will be called to defend these properties when fire threatens.

Significant concerns about this site have been identified in the past, including by the former NSW Planning Assessment Commission which blocked development in 2009 in the Oxford Falls Valley, including this site, because of concerns about fire.

This current proposal was developed on the premise of evacuation being provided by Morgan Road, including a new slip lane onto Forest Way and a new emergency access onto Oates Place but the availability and utility of these aspects have not been demonstrated in the proposal.

It also depends on asset protection zones (APZs) and housing being built to resist ember attack. These measures, described in the proponent's Bushfire Risk Assessment, depend on high levels of maintenance by council and by homeowners to be effective.

They are also based on historical understandings of fire behaviour. As recent bushfire incidents in NSW have shown, past fire behaviour is no longer a guide to future risk as the climate changes. As former New South Wales fire and rescue commissioner and Climate Council member Greg Mullins said: "We're going to have fires that I can't comprehend, and I've been in the game for nearly half a century."

Environmentally destructive, carbon intensifying

The destruction of precious bushland adjacent to the National Park at a time when we are trying to reduce the impact of climate change and reverse the decline in threatened species is unacceptable.

State governments have multiple policies about greening the city, reducing the impacts of a heating environment and protecting our biodiversity.

This development also goes against treaties the federal government has committed to regarding preserving the natural environment and arresting the decline in threatened species. This includes the Kunming-Montreal treaty on Biodiversity which commits Australia to conserving 30% of all land by 2030. NSW currently has less than 10% under protection as national parks and reserves. In achieving this aim of conserving 30% of all land, it is crucial that a diverse range of natural environments are protected across the state, including in coastal and urban regions.

The proposal also would have significant adverse impacts on the state's carbon footprint. Work by <u>Sydney University</u> has found that the impact of deforestation of the Lizard Rock site would result in a surplus of 6,390 tonnes of CO2 being released into the atmosphere.

The cost of purchasing offsets or reforesting an equivalent area is likely to be significant and should be considered as part of the decision making about whether this development should proceed.

Pressure on infrastructure

The clearing and developing of such a large area will exacerbate the already significant flooding issues on the Wakehurst Parkway. The Wakehurst Parkway is a major arterial road for residents of the Northern Beaches to access both the Northern Beaches Hospital and the city and its frequent flooding is one of the community's great local concerns.

The Northern Beaches Council has been allocated over \$30 million from the NSW State Government to dredge the river in the valley adjacent to the Wakehurst Parkway. Currently this road floods on average 6-7 times a year closing the road and thus cutting of the main access for thousands of residents to the Northern Beaches Hospital. This development will undoubtedly lead to further silting up of the river and exacerbate the flooding problems of the Wakehurst Parkway, which have been a major concern for Mackellar residents for decades.

Clearing of bushland upstream from the Parkway and replacing it with nonpermeable roads and other surfaces is also likely to exacerbate the flooding problem, requiring more state spending on drainage.

The proposal will also put further pressure on existing infrastructure, including requiring significant road upgrades to ensure safe and swift access and exit to the site.

An alternative plan

The community and I accept and support the MLALC's mission to generate income to secure the financial future of First Nations peoples across Sydney.

There are alternative plans that could be considered. The State Government should step in and purchase the land or agree to a longer-term lease before transforming the land into an Aboriginal Owned National Park, as was originally suggested by the MLALC back in 2013.

The government should also explore compensation for the land being preserved as a carbon offset.

This would be a win-win-win situation: the MLALC secures a financial gain in addition to the long term jobs that are created for Indigenous people within the National Park, while the local community will benefit from additional valuable open space and recreational and cultural spaces.

While I understand the Metropolitan Local Aboriginal Land Council's (MLALC) desire to realise the potential profit in these land holdings, clearing high value bushland for low density housing is out of step with modern planning principles and condemns future residents to extreme bushfire risk and car dependency.

Dear Sir/Madam

I am a local resident on the Northern Beaches and am writing to oppose the proposed rezoning of land at Patyegarang, Morgan Road, Belrose, or "Lizard Rock" (PP-2022-3802). I write on behalf of those who cannot write a submission for themselves — the wildlife that live at Lizard Rock, and the future generations who have a right to a healthy natural environment.

This proposal must be refused for the following reasons:

- Loss of habitat for iconic species of flora and fauna such as swamp wallabies. This bushland forms part of a wildlife corridor connecting private land, Garigal National Park, and Narrabeen Lagoon State Park. This area has high biodiversity value and is irreplaceable.
- Impacts on the Narrabeen Lagoon Catchment as stormwater from the development will flow downhill, with less bushland to filter the water before it enters the estuary. This will impact on threatened species including the red-crowned toadlet and spotted-tail quoll , and on marine animals that live in the lagoon.
- Loss of Sydney's Green lungs as trees are renowned for their ability to improve air quality, help to cool urban areas, and draw down carbon from the atmosphere into the ground. With the threat of climate change, every tree plays an important role in drawing down carbon and helping to mitigate urban heat impacts.
- Some of the sites are at significant risk of bushfire events. This would mean we are building
 houses in places we know that people may not be safe in the future. Northern Beaches Council
 has obtained independent advice on bushfire risks at the Lizard Rock site, which identified that
 the site includes areas of Very High Extreme risk. The report also identified concerns about the
 safety and viability of evacuation. This proposal will likely require significant asset protection
