

I am a local resident on the Northern Beaches and am writing to oppose the proposed rezoning of land at Patyegarang, Morgan Road, Belrose, or "Lizard Rock" (PP-2022-3802). I write on behalf of those who cannot write a submission for themselves – the wildlife that live at Lizard Rock, and the future generations who have a right to a healthy natural environment. This proposal must be refused for the following reasons:

- Loss of habitat for iconic species of flora and fauna such as swamp wallabies. This bushland forms part of a wildlife corridor connecting private land, Garigal National Park, and Narrabeen Lagoon State Park. This area has high biodiversity value and is irreplaceable.
- Impacts on the Narrabeen Lagoon Catchment as stormwater from the development will flow down hill, with less bushland to filter the water before it enters the estuary. This will impact on threatened species including the red-crowned toadlet and spotted-tail quoll, and on marine animals that live in the lagoon.
- · Loss of Sydney's Green lungs as trees are renown for their ability to improve air quality, help to cool urban areas, and draw down carbon from the atmosphere into the ground. With the threat of climate change, every tree plays an important role in drawing down carbon, and helping to mitigate urban heat impacts.
- Some of the sites are at significant risk of bushfire events. This would mean we are building houses in places we know that people may not be safe in the future. Northern Beaches Council has obtained independent advice on bushfire risks at the Lizard Rock site, which identified that the site includes areas of Very High – Extreme risk. The report also identified concerns about the safety and viability of evacuation. This proposal will likely require significant asset protection zones, which would further erode the wildlife corridor.
- Traffic and urban sprawl this proposal will create problems with urban sprawl, as more houses are built away from urban centres, and so the residents will be reliant on cars, rather than being within a short walk or bus ride to places. This will contribute towards local traffic congestion on Forest Way, Wakehurst Parkway, and Warringah Road.

I write as a long-time resident of Sydney's Northern Beaches, whose professional career has (over several decades) focused on just outcomes for our environment. Having served as an elected Local Government representative, a full-time consultant to a former Federal Environment Minister, and the co-owner/director of a successful consultancy business that sought to bring together competing interests in environmental, social and economic outcomes, I feel that I bring to this issue reasonably informed perspectives. These are complemented by more than a decade of service as a statutory representative of the Nature Conservation Council on local bushfire committees.

It is in this context that I submit my opposition to the Planning Proposal for the Metropolitan Local Aboriginal Land Council (MLALC) site on Morgan Road at Belrose (referred to in this submission as 'the proposal').

I acknowledge at the outset that MLALC rightly has expectations, under the provisions of the *NSW Aboriginal Land Rights Act 1983*, of opportunities to manage land to enhance the economic position of Aboriginal communities as compensation for historic dispossession and ongoing disadvantage. **However, the Morgan Road proposal for a 450 dwelling residential development is a case of the wrong proposal in the wrong place**. Furthermore, as a long-time member of the Manly Warringah Pittwater Aboriginal Support Group, I am aware that First Nations people with significant attachment to the Northern Beaches are not in support of this proposed development.

My concerns with the proposal are numerous and diverse, and are not allayed by the supporting documents provided in relation to the Patyegarang Project Planning Proposal.

Bushfire risk

To propose that 450 residential dwellings be developed on the Morgan Road Belrose site, which is largely surrounded by bushland, fails to take adequate account of potential for bushfire risk from ember attack and/or directly from radiant heat.

Fire risk 'Focus Area'

The site is one which has been identified both by Northern Beaches Council and by the relevant Bushfire Management Committee in its recent update of the Northern Beaches Bushfire Management Plan, as "a Focus Area" which has a significant bushfire risk profile. In identifying the Belrose/Davidson area (which includes the Morgan Road site) as a 'Focus Area' the Northern Beaches

Bush Fire Risk Management Plan (2023) cites as prime considerations in defining this as a Focus Area "The variation in vegetation types, topography, proximity to assets and potential for rapid impact in the event of a bushfire...". With 20ha of bushland to be retained in the 71ha Patyegarang site, these are significant concerns for future safety of the residents.

Both in the Bush Fire Risk Management Plan and in the Strategic Bushfire Study recently completed by Travers Bushfire & Ecology (26 July 2023) there is a heavy reliance on mitigation measures (primarily Asset Protection Zones and fuel managed areas) to address these substantial risks. The Travers study, in its concluding remarks, acknowledges that "The surrounding area is one of significant fire potential", and that "Past fires in the wider area have resulted in significant threat to life and property".

Risk exacerbated by climate change

In her presentation to the biennial national bushfire conference (Sydney, May 2023) Manager of Research & Development at the Victorian CFA, Dr Sarah Harris highlighted the fact that "Climate change is influencing our fire weather and the severity of our fire seasons, and this is projected to worsen". This is a view often expressed by former long-time Fire & Rescue NSW Commissioner Greg Mullins and many of his colleagues in Emergency leaders for Climate Action.

As recent summers in New South Wales have demonstrated, fires of previously largely unknown intensity and extent are occurring in the face of climate change, often with a significant challenge presented by forward projection of ember attack. The national Fire Danger Index has been expanded to include an additional category (Catastrophic) sitting at a higher risk level than was previously on that scale, and already on 1 October 2023, Sydney had experienced its hottest October day on record; strong indicators of more challenging fire control conditions ahead.

Reliance on Asset Protection Zones & Hazard Reduction Burning

In these circumstances, heavy reliance on "wide" Asset Protection Zones (up to 100 metres wide, based on Bushfire Attack Level – BAL - calculations) can only mean increased clearing of native vegetation both within the proposed development site and in surrounding bushland areas, together with Hazard Reduction burning at the lower end of the 'preferred fire intervals' for the various vegetation types present. Whether or not increased frequency of Hazard Reduction burning actually reduces fuel loads over time is the subject of significant debate both within fire services and in wider fire science circles. Already there is growing evidence that fuel loads in some areas burnt during the 2019/20 'Black Summer' bushfires may exceed those prior to those fires.

While every effort should be made to conserve native vegetation in natural condition to provide habitat corridors for wildlife, the proposed retention of 6.9ha of native vegetation "in a natural condition ... in reserves and corridors within the development zone of the property" (as addressed in the Hayes Environmental report, July 2023, p.iii) will surely add to the risk of ember attack during any bushfire in the vicinity. — a concern acknowledged in the Hayes Environmental report, which recognised that the "natural condition" of these corridors is "at risk of indirect and uncertain impacts".

Travers Bushfire & Ecology (July 2023, p.16) also recognises that "The possibility of ember attack from fires emanating from the North West, North and North East is not eliminated however and embers may land within the proposed site from fires several kilometres away".

Evacuation options

As recognised by Travers Bushfire & Ecology (July 2023, p.23) "access to and egress from the site will be critical for the safety of attending emergency services and residents. To this end, the provision of significantly enhanced access infrastructure is proposed. This upgrade includes the provision of a slip

lane allowing traffic to turn unhindered by traffic management devices from the northern end of the Patyegarang project site to a southerly direction along Forest Way".

The Independent Planning Panel Review (p.9) states clearly that "Any planned future development will require identification of the relevant funding mechanism to support additional infrastructure" and that "... this should be undertaken early in the planning process".

There is no evidence in the various documents provided as part of the Independent Planning Panel Review, that such funding mechanisms have been identified. This may well be considered one of the various "inconsistencies" in the Planning Panel's Gateway Determination that led the dissenting Panel member to conclude that "the proposal [does] not demonstrate the suitability of the proposal to adequately respond to the environmental and other constraints of the site".

Loss of biodiversity

<u>Habitat</u>

That 76% of people making submissions in response to the development proposal raised concerns about biodiversity loss and threatened species points to an issue that must be adequately addressed before the Patyegarang ('Lizard Rock') planning proposal is allowed to proceed.

The Independent Planning Panel Review (s.5.1, p.8) recognises "Under the Biodiversity Offset Scheme, applications for development or clearing approvals must set out how impacts on biodiversity or clearing approvals will be avoided and minimised...".

Although the Hayes Environmental Preliminary Report (July 2023) addresses requirements for impact avoidance and minimisation to a limited extent, it acknowledges the presence of at least four threatened species, but then appears to begin with an assumption that 'offsets' will address the conservation of these species. The option of **avoiding** impacts by considering other uses for the site does not receive further consideration. Since amendments to the NSW Biodiversity Conservation Act weakened requirements for 'like for like' considerations in offsetting and enabled payment of a fee to 'offset' losses by supporting conservation of another species elsewhere, significant concerns are frequently expressed as to the ability of 'offsetting' to ensure no nett loss of a threatened species.

Beyond these threatened species, greater consideration should be given to meaningful retention of habitat for a wider range of native species present across the site and nearby, the connectivity of bushland corridors providing habitat important to the genetic diversity of local species, and the disruptions caused by the need for Asset Protection Zones of up to 100m width and local roadways throughout the site (as indicated by Travers Bushfire &Ecology, July 2023). The proposed development, and the loss and fragmentation of habitat that it would bring, increase the likelihood that other native species found in the area, such as Powerful and Barking Owls, and Rosenberg's Goanna, will join the threatened species lists.

As the impacts of climate change are increasingly recognised, there is a growing body of evidence of the importance of retained bushland areas both in mitigating urban heat-sink effects and in providing outdoor recreational places that improve human health and well-being.

That residents of the Northern Beaches value these amenity attributes is strongly recognised. Based on input from some 2000 residents, the Community Strategic Plan 2028, adopted by Council in April 2018, identified as its vision: Northern Beaches – A safe, inclusive and connected community that lives in balance with our extraordinary coastal and bushland environment.

The Lizard Rock bushland area, with its connections to Garigal National Park and the Narrabeen Lagoon State Park, is a popular outdoor recreation area for walkers, cyclists and others in the vicinity and across the Northern Beaches.

Water quality impacts

Clearing of vegetation, road surfaces, hardstand areas and other surfaces in the developed area will contribute increases in stormwater runoff that affect water quality in local waterways, with potential to adversely affect both local wetlands and the water quality of Narrabeen Lagoon. These are matters that need to be addressed before the development proposal reaches the DA stage.

Lack of congruence with more holistic Northern Beaches strategic planning

Northern Beaches Council is undertaking strategic planning to address housing needs in a holistic way across the Local Government Area.

Consistent with sound planning principles, proposed zoning & resident numbers focus intensification in places that provide shopping and other services necessary to day-to-day living and those that are readily accessible to public transport. By contrast, the Patyegarang site proposes 450 residential dwellings in an area that lacks adequate public transport, and where access to everyday services such as shops and schools, would be highly car-dependent. This, in turn, would add to existing traffic congestion in an area constrained to one major road in and out.

While the Patyegarang proposal is for 450 dwellings, the proposed R2 residential zoning enables weakened enforcement that could see the addition of 'granny flats' or other subsidiary dwellings, enabling a significantly higher total population on the site than is implied in the stated 450 dwellings.

In August 2023, MLALC wrote to the Sydney North Planning Panel indicating their intentions in relation to provision of 'affordable housing' on this site. As is indicated in that correspondence, where the Northern Beaches Affordable Housing Contribution Scheme is applied, the expectation is that 10% of the total floor space of approved building will be dedicated to affordable housing. MLALC seeks to claim what appear to be concessions on the basis that their site is a greenfield site, requiring "provision of substantial enabling infrastructure", such that their provision would be for 20 affordable dwellings rather than the 45 implied if 10% of the total dwellings were to be provided.

Given that aspects of the provision of enabling infrastructure (including the proposed slip-road necessary for safe egress from the site in bushfire or other emergencies) do not appear to be included in the proposal as presented, the validity of this 'concession' cannot be assessed at present. Since Northern Beaches Council has identified more suitable sites, for which necessary infrastructure and services are available, it should not be expected that Council and its ratepayers will bear the cost of new services required for this affordable housing.

As identified in the Independent Planning Review (May 2022, p.8) "Any future planning proposal and DA must provide sufficient documentation to determine accurate infrastructure requirements to support the development, including utilities, services, roads, recreational and community facilities etc". To date, this does not appear to have been adequately addressed.

Rarely is 'Spot zoning' a sound approach to systematic and well-researched town planning, and this is applicable to the current Patyegarang site proposes. Not only is the R2 zoning proposed for this site inconsistent with Northern Beaches conservation proposed zoning for this area, but to apply this spot zoning to this land sets a precedent that will likely be inappropriate for other areas of conservation significance that are sought by MLALC or other developers for residential development.

In conclusion, I urge the rejection of the proposed housing development and its replacement with:

- An appropriate land swap, with residual, currently vacant land at Balgowlah Golf Club (595-597
 Warringah Road, Frenchs Forest) or other vacant Crown Land; or
- Incorporation of the site into Garigal National Park, with this portion placed under First Nations management and with revenue from a lease-back fee, educational tours and events, and fees from ecotour groups and others contributing to MLALC in financial recognition of the Aboriginal peoples' rights to enhancement of the economic benefits to be had from this land. Booderee National Park at Jervis Bay provides a model for such arrangements.
 This latter proposal would be entirely consistent with a past proposal for an Aboriginal owned Gaimariagal National Park a proposal that received serious consideration during negotiations between MLALC, National Parks & Wildlife Service, the then Minister for Environment and



I object to this planning proposal on the grounds that:

The planning proposal has significant planning, environmental and hazard issues, including:

Bushfire risks – the site is in a high bushfire risk area. We know this from the 1994 bushfires. Evacuation will be a problem. No upgrades to Morgan Road are proposed. A new slip lane onto Forest Way requires acquisition of Council land and a new emergency egress proposed via Oates Place is proposed to be gated and available only during a fire event raising concerns about it practicality.

Inconsistency with planning strategies – The proposal is inconsistent with key aspects of the Greater Sydney Region Plan, North District Plan, Northern Beaches Local Strategic Planning Statement – Towards 2040, and Northern Beaches Local Housing Strategy, particularly in terms of the preferred location and type of new housing and impacts on the environment and Metropolitan Rural Area.

Inconsistency with Council's Conservation Zones Review – The Review recommends applying a C3 Environmental Management Zone to most of the site due to its high environmental value and high rick of bushfires. The Preliminary Biodiversity Development Assessment Report, July 2023 version, itself states it still finds all vegetation across the subject land are classed as being in good or intact condition; intact Heath, intact Woodland and intact Forest. Further this document does not seem to be aware of some species of wildlife and plant communities known to be present.

Enormous loss of high biodiversity habitat – With 44.7 hectares of bushland to be cleared, the proposal and new development will have significant environmental impact. Given the scale of development, I am not satisfied that waterways within the site can be protected and the quality of run-off to Narrabeen Lagoon can be controlled.

The amount of 'offsets' required to raze this land and kill all the wildlife thereby that lives in and on it, such as the Eastern pygmy Possum, amounts to thousands of required 'credits to be retired'. The BAM Biodiversity Credit Report (Like for like) lists Pittwater, Cumberland, Sydney Cataract, Wyong and Yengo or any IBRA subregion that is within 100 kilometres of the outer edge of the impacted site[Interim Biogeographic Regionalisation for Australia].

However, in missing the endangered Angus's Onion Orchids that grow here, that occurs on soils in the restricted ridgetop lateritic soils in the Duffys Forest - Terrey Hills - Ingleside and Belrose areas - the 'like for like' may be difficult. These soils support a specific and distinct vegetation type, the Duffys Forest Vegetation Community, which is listed as an endangered ecological community under the TSC Act and ranges from open forest to low open forest and woodland; intact Heath, intact Woodland and intact Forest.

Council states it has previously written to federal and state MPs, along with relevant ministers, proposing an alternative solution and financial model so that MLALC can still benefit financially from its land, while the land is protected in perpetuity. Why hasn't this been pursued?

I do not want the Patyegarang Lizard rock development to be approved.

I was present at a recent community meeting where two local Guringai Indigenous elders spoke, one of which sits on the advisory committee for National Parks and Wildlife Service Metro north east and is also a director of the Guringai Tribal Link Aboriginal Corporation.

They are custodians of the land. Their voices have not been included in the newly named Patyegarang Morgan Road Belrose/Oxford Falls development proposal.

As local custodians the lack of consultation means they have NOT BEEN INCLUDED in how the area could be managed.

The Guringai elders view the entire 71 hectares earmarked for development as traditional cultural land, which includes culturally significant sites. The elder has stated 'She is our lady, she is our mother, we look after the land. To us it should stay bush forever.' The local elder teaches children about culture and caring for the land. I object to the land becoming privatised and no longer accessible to the local Aboriginal community and the community as a whole. As a teacher I also object to local children having no access to this space for learning about country as immersion is important for being culturally aware.

The UN Declaration on the Rights of Indigenous Peoples states:

Article 25

Indigenous peoples have the right to maintain and strengthen their distinctive spiritual relationship with their traditionally owned or otherwise occupied and used lands, territories, waters and

coastal seas and other resources and to uphold their responsibilities to future generations in this regard.

Article 26

States shall give legal recognition and protection to these lands, territories and resources. Such recognition shall be conducted with due respect to the customs, traditions and land tenure systems of the indigenous peoples concerned (LOCAL GURINGAI PEOPLE).

Article 27

States shall establish and implement, in conjunction with indigenous peoples concerned, a fair, independent, impartial, open and transparent process, giving due recognition to indigenous peoples' laws, traditions, customs and land tenure systems, to recognize and adjudicate the rights of indigenous peoples pertaining to their lands, territories and resources, including those which were traditionally owned or otherwise occupied or used. Indigenous peoples shall have the right to participate in this process.

The proposal breaches this declaration as local traditional owners will NOT HAVE ACCESS to this land once it is developed and privatised.

The NSW government is committed to building multi-storey units which are more appropriate for maintaining public spaces rather than urban sprawl. Low to medium density housing leaves very little spaces to be enjoyed by the community as proposed in this development. This is another reason why I am in opposition to this.

Narabeen Lagoon will be affected irreversibly due to runoff from driveways and gutters. Currently vegetation and trees act as a buffer against flooding into the lagoon. Engineering this currently steep topography will allow for flooding in the future due to tree removal. Urban runoff also encourages chemicals to seep into rivers which will drive further pollution and environmental degradation.

The area is prone to bushfires. When houses are built fire driven from nearby national parks will burn houses and not bushland. Poisonous chemicals emitted will burn from houses which are much more dangerous. This is not addressed in the plans and I quote 'A detailed bushfire assessment will need to be undertaken...to ensure the site is suitable for residential development,' indicating the development proposal has not been properly fire assessed and not available for public consultation until DAs have been submitted.

The impacts on local wildlife will be irreversible as this backs onto a national park. Once animals lose their habitat they will die. There is already pressure on the environment with climate change, this will put further stress on the environmental ecology in the area.

How are the local community going to be compensated while the development occurs? There are few roads in and out of the northern beaches. Wakehurst Parkway, Forestway, Warringah Rd and Mona Vale Road will be congested for commuters resulting in loss of productivity. Wakehurst Parkway The NSW government will not have the money to do this. I am sure developers will not want to do this either. The proposal does not outline how it is going to mitigate these problems. How is a slip road going to solve this problem? It has not been explained.
