I am a local resident on the Northern Beaches and am writing to oppose the proposed rezoning of land at Patyegarang, Morgan Road, Belrose, or "Lizard Rock" (PP-2022-3802). I write on behalf of those who cannot write a submission for themselves - the wildlife that live at Lizard Rock and the future generations of youth living on the Northern Beaches who have a right to a healthy natural environment and bushland without overcrowded community areas, schools and further traffic congestion.

Furthermore, I raise concerns on behalf of Aboriginal-identifying individuals on the Northern Beaches who have had limited interactions with Metro Aboriginal Land Council and are concerned about the ongoing support to maintain and showcase Aboriginal heritage and culture on the Northern Beaches.

This proposal must be refused for the following reasons:

- 1) Loss of habitat for iconic species of flora and fauna such as swamp wallabies. This bushland forms part of a wildlife corridor connecting private land, Garigal National Park, and Narrabeen Lagoon State Park. This area has high biodiversity value and is irreplaceable.
- 2) Impacts on the Narrabeen Lagoon Catchment as stormwater from the development will flow downhill, with less bushland to filter the water before it enters the estuary. This will impact on threatened species including the red-crowned toadlet and spotted-tail quoll, and on marine animals that live in the lagoon. In recent years the black swan population from Narrabeen Lagoon has started to thrive and grow in numbers due to improved quality of water and ecosystem through the work many organisations and Northern Beaches Council have done to clean up the Lagoon Catchment area. This development would reverse this work and set back the ecological work that has proven improvements.

- 3) Loss of Sydney's Green lungs as trees are renowned for their ability to improve air quality, help to cool urban areas, and draw down carbon from the atmosphere into the ground. With the threat of climate change, every tree plays an important role in drawing down carbon, and helping to mitigate urban heat impacts. Furthermore, it is known that this site is home to many birds and wildlife including the glossy black cockatoo that feeds on casuarina trees on and around this site, the regent honeyeater that nests in gum trees and casuarinas and are threatened by land clearing and the southern brown bandicoot that frequent areas of Terry Hills, Narrabeen and Belrose areas.
- 4) Some of the sites are at significant risk of bushfire events. This would mean we are building houses in places we know that people may not be safe in the future. Northern Beaches Council has obtained independent advice on bushfire risks at the Lizard Rock site, which identified that the site includes areas of Very High Extreme risk. The report also identified concerns about the safety and viability of evacuation. This proposal will likely require significant asset protection zones, which would further erode the wildlife corridor. The Northern Beaches is a tight-knit community with many connections to our Rural Fire Service volunteers and does not want community members put at risk by either an extreme risk of bushfires for their homes or needing to send volunteers to fight fires and protect homes for new developments.
- 5) Traffic and urban sprawl this proposal will create problems with urban sprawl, as more houses are built away from urban centres, and so the residents will be reliant on cars, rather than being within a short walk or bus ride to places. This will contribute towards local traffic congestion on Forest Way, Wakehurst Parkway, and Warringah Road. Furthermore, with more cars flowing onto Forest Way, speed limits will need to be changed leading to greater congestion to ensure safety for all. This will have a flow-on effect to Mona Vale Rd which has already been identified as a road safety hazard, yet funding to continue urgent upgrade and widening of this road has been paused under the new Government budget. This will also have impacts on Oxford Falls Rd which is frequently closed due to flooding and is not a reliable exit from the proposed development site. There needs to be consistent traffic infrastructure planned and committed action taken to address these issues before significant housing developments can be made on this site.
- 6) Broader Strategic planning implications the proposed housing is happening in isolation to the broader strategic planning being done by Northern Beaches Council to meet housing needs and plan for issues such as traffic and services in a holistic way across the entire Northern Beaches. This will create further issues for the already community-approved and agreed-upon development plans that will sustainably support the future of the Northern Beaches.
- 7) Negative precedent in the deferred lands The Northern Beaches Council is undertaking a strategic review of land use in the Metropolitan Rural Area in Oxford Falls and Belrose. Using an evidence-based approach, the Council's draft plans are to zone private land in this area as Rural and C3 Environmental Management zoning. Approving the planning proposal would create an inappropriate precedent that other landowners in the MRA can also seek a spot rezoning, further eroding the remaining bushland on private land and posing greater risks to endangered biodiversity in the Oxford Falls and Terrey Hills areas.
- 8) The Metropolitan Aboriginal Land Council does minimal engagement and support for the Aboriginal community groups within the Northern Beaches and has no committed plans to financially support the awareness of Aboriginal heritage on the Northern Beaches and the longevity of cultural practices of Northern Beaches Indigenous community members. If this land is for the benefit of Aboriginal people, there should be plans within this development to significantly support local Aboriginal and Torres Strait Islander community members, organisations and the general education and protection of Aboriginal heritage on the Northern Beaches. Landscaping and artwork should be sourced locally, and there must be a commitment to funding or facilitating programs that support the thriving Aboriginal culture on the Northern Beaches.

Why is this a bad idea:

- 1. It sets a present for hundreds of hectares of bush across the Northern Beaches to be changed from "environmental" zoning to residential. PLUS across the Central and South coast. There are developers watching the outcome.
- 2. There is no infrastructure at the proposed site. No sewerage. Electricity. Paths.Internet. And 1 single lane road in and out for at least 450 homes/ 1500 people to get in and out.

There are also compensation options for the developer.
- 8. We can not and should not clear any more trees! There are many infill development options. If this goes ahead it sets a terrible precedent for all the privately owned vegetation that surround our national parks. It will also have big run off issues adding sentiment to Narrabeen Lagoon.
- 9. Council, our local and federal MPS are in majority opposed. It isn't just a few 'nimbies'. This is an awful idea that should let have made it this far in planning...but something strange is going on. No one can understand why this proposal has made it this far....I wonder....

Deforestation is not an acceptable choice in this age of environmental awareness. Australia currently holds the highest rate of mammal extinction IN THE WORLD. It is our responsibility to actively work to stop this.

There are many endangered and vulnerable species in the development zone, echidnas, powerful owls, glossy black tailed cockatoos, swamp wallabies, red crown toadlets, swamp wallabies, yellow tailed black cockatoos rosenbergs Goana womgbates, quolls and koalas to name a few, as well as calyi grevillia, dianella berries, Waratah, flannel flowers, Christmas bells, angophra trees (of which the ridegeline ones are part of an indigenous cemetery).



- 10. A negative precedent in the deferred lands. The Northern Beaches Council is undertaking a strategic review of land use in the Metropolitan Rural Area in Oxford Falls and Belrose. Using an evidence based approach, the Council's draft plans are to zone private land in this area as Rural and C3 Environmental Management zoning. Approving the planning proposal would create an inappropriate precedent that other landowners in the MRA can also seek a spot rezoning, further eroding the remaining bushland on private land.

This valuation of \$800k per site is grossly undervalued compared to the NSW Valuer Generals 30/6/2022 valuations of adjacent Belrose land for domestic dwellings. The per site unimproved value should be around \$1.6m which is twice the Proposal's valuation.

Therefore even 10% of the unimproved value of the development should be approximately \$72m.

MLALC proposes to have a third party build 20 dwellings, not 10% of dwellings proposed. The 10% for affordable dwelling should be based on 10% of the whole development's floorspace, which should amount to many more than 45 dwellings.

The Proposal suggests the MLALC will not be building any of the 450 dwellings, but will sell off the land subsequent to: "Improved value as a result of rezoning, includes land clearing, services, delivery of roads & infrastructure, subdivided and ready for construction by others." (MLALC commitment for the Provision of Affordable Housing dated 18th August 2023 to Mr Debnam, Chair of the Sydney North Planning Panel.) How will the appropriate affordable housing (10% of the approved DAs floorplan area) be built if the rezoned land is sold by MLALC lot by lot?

Further, MLALC proposes that it will decide who will be selected to inhabit this affordable housing, and will determine what will happen to these dwellings after 15 years. So MLALC will own this affordable housing and control it's usage. It should be determined by the NSW Government like all affordable housing.

Surely as the indigenous owners of this land they would have done extensive searches for these as yet unidentified artifacts so that they can be documented and protected from damage from development.

I believe no development should progress until the MLALC has done a thorough search for these indigenous cultural artifacts.

Land Use - Biodiversity and Endangered Species



We note with huge dismay/sadness the onward progression of the planning for the proposed Lizard Rock Development in Belrose. We have lived in the area for 11 years and our family and friends have enjoyed the peaceful, scenic drive down Morgan Road, past Lizard Rock, as a highlight of the wonderful diversity in fauna and flora offered in Australia. We believe it will be a travesty to allow the demolition of this national treasure largely for commercial reasons, so I am writing to oppose the proposed rezoning of land at Patyegarang, Morgan Road, Belrose, or "Lizard Rock" (PP-2022-3802). I believe the proposal must be refused for the following reasons:

- 1. The significant loss of high biodiversity habitat. With around 45 hectares of bushland to be cleared. Several endangered species, both fauna and flora, exist in this area. This whole area has already been identified as an area applicable for a C3 Environmental Management Zone site due to its high environmental value and hazards that impact the site, so it is not suitable for development at all. A threatened plant species, Tetratheca glandulosa, has been recorded at several locations within the subject land and another, Cryptostylis hunteriana, is also assumed present. Two endangered fauna that occur in the area are the Red-crowned Toadlet and the Eastern Pygmy possum. By eradicating their habitat, the development will significantly reduce, or in cases totally eliminate the presence of endangered and nonendangered animals from the area. This is one of the last remaining breeding grounds for Black Cockatoos.
- 2. **Cats & Dogs will threaten wildlife.** Once developed, the remaining animals will be further threatened by the introduction of domestic cats and dogs.
- 3. Significant risk of bushfire events. The proposal proposes to build houses in places we know that people may not be safe in the future. Northern Beaches Council has obtained independent advice on bushfire risks at the Lizard Rock site, which identified that the site includes areas of *Very High to Extreme risk*. The report also identified concerns about the safety and viability of evacuation. This proposal will likely require significant asset protection zones, which would further erode the wildlife corridor.

- 4. **Impacts on the Narrabeen Lagoon Catchment.** As stormwater from the development will flow down hill, with less bushland to filter the water before it enters the estuary. This will impact on threatened species including the red-crowned toadlet and spotted-tail quoll in the bushland, and on marine animals that live in the lagoon.
- Previous Development Applications Blocked. The area was previously blocked for development after the Planning Assessment Commission reported the area as a sub catchment for Narrabeen Lagoon.
- 6. **Threat to Aboriginal Heritage Sites.** Aboriginal heritage sites and ancient carvings that are present in the area would likely be subject to vandalism and maltreatment.
- 7. **Traffic and Access Insufficient.** The proposed slip lanes on Oates Place and Forest Way are on Council Land and not zoned for this purpose the availability and utility of this has not been adequately demonstrated. Also, insufficient explanations of traffic and transport proposals 400 plus homes in the middle of the bush, not connected to any services.
- 8. **Urban sprawl.** The proposal will create problems with urban sprawl, as more houses are built away from urban centres, and so the residents will be reliant on cars, rather than being within a short walk or bus ride to places. This will contribute towards local traffic congestion on Forest Way, Wakehurst Parkway, and Warringah Road.
- 9. Broader Strategic planning implications. The proposed housing is happening in isolation to the broader strategic planning being done by Northern Beaches Council to meet housing needs and plan for issues such as traffic and services in a holistic way across the entire Northern Beaches.
- 10. A negative precedent in the deferred lands. The Northern Beaches Council is undertaking a strategic review of land use in the Metropolitan Rural Area in Oxford Falls and Belrose. Using an evidence based approach, the Council's draft plans are to zone private land in this area as Rural and C3 Environmental Management zoning. Approving the planning proposal would create an inappropriate precedent that other landowners in the MRA can also seek a spot rezoning, further eroding the remaining bushland on private land.



We note with huge dismay/sadness the onward progression of the planning for the proposed Lizard Rock Development in Belrose. We have lived in the area for 11 years and our family and friends have enjoyed the peaceful, scenic drive down Morgan Road, past Lizard Rock, as a highlight of the wonderful diversity in fauna and flora offered in Australia. We believe it will be a travesty to allow the demolition of this national treasure largely for commercial reasons, so I am writing to oppose the proposed rezoning of land at Patyegarang, Morgan Road, Belrose, or "Lizard Rock" (PP-2022-3802). I believe the proposal must be refused for the following reasons:

- 1. The significant loss of high biodiversity habitat. With around 45 hectares of bushland to be cleared. Several endangered species, both fauna and flora, exist in this area. This whole area has already been identified as an area applicable for a C3 Environmental Management Zone site due to its high environmental value and hazards that impact the site, so it is not suitable for development at all. A threatened plant species, Tetratheca glandulosa, has been recorded at several locations within the subject land and another, Cryptostylis hunteriana, is also assumed present. Two endangered fauna that occur in the area are the Red-crowned Toadlet and the Eastern Pygmy possum. By eradicating their habitat, the development will significantly reduce, or in cases totally eliminate the presence of endangered and nonendangered animals from the area. This is one of the last remaining breeding grounds for Black Cockatoos.
- 2. **Cats & Dogs will threaten wildlife.** Once developed, the remaining animals will be further threatened by the introduction of domestic cats and dogs.
- 3. Significant risk of bushfire events. The proposal proposes to build houses in places we know that people may not be safe in the future. Northern Beaches Council has obtained independent advice on bushfire risks at the Lizard Rock site, which identified that the site includes areas of *Very High to Extreme risk*. The report also identified concerns about the safety and viability of evacuation. This proposal will likely require significant asset protection zones, which would further erode the wildlife corridor.

- 4. **Impacts on the Narrabeen Lagoon Catchment.** As stormwater from the development will flow down hill, with less bushland to filter the water before it enters the estuary. This will impact on threatened species including the red-crowned toadlet and spotted-tail quoll in the bushland, and on marine animals that live in the lagoon.
- Previous Development Applications Blocked. The area was previously blocked for development after the Planning Assessment Commission reported the area as a sub catchment for Narrabeen Lagoon.
- 6. **Threat to Aboriginal Heritage Sites.** Aboriginal heritage sites and ancient carvings that are present in the area would likely be subject to vandalism and maltreatment.


