# CONDITIONS OF CONSENT DEVELOPMENT APPLICATION No. 08-06-2012

## PART A – ADMINISTRATIVE CONDITIONS

#### A1 Development Description

Development Consent is granted only to carrying out of the development as described, and at the premises referred to, in **Schedule 1** above.

These conditions of this consent do not relieve the proponent of its obligations under the *Environmental Planning and Assessment Act 1979*, and any other Act.

#### A2 Development in Accordance with Plans

The development shall be undertaken in accordance with the following drawings:

Plans prepared by REID CAMPBELL P/L, Project No. 110113, Drawing No. 01 (Issue B, dated 3/07/2012), No. 02 & 3 (Issue C, dated 6/07/2012), and No. 04 (Issue B, dated 4/07/2012),

except for:

- any modifications which are 'Exempt and Complying Development' as identified in the relevant State Environmental Planning Policy (SEPP) or as may be necessary for the purpose of compliance with the Building Code of Australia (BCA) and any Australian Standard (AS) incorporated in the BCA;
- 2. otherwise provided by the Conditions of this Consent;
- 3. otherwise as necessary to comply with other NSW and Commonwealth legislation.

#### A3 Inconsistency between documents

In the event of any inconsistency between Conditions of this Consent and the details referred to in Condition No. A2, the Conditions of this Consent prevail.

#### A4 Lapsing of Consent

This consent will lapse five (5) years from the date of this consent unless the development has physically commenced.

#### A5 Prescribed Conditions

The Proponent shall comply with the prescribed conditions of development consent under Clause 98 of the *Environmental Planning and Assessment Regulations 2000* in relation to the requirements of the BCA.

## A6 Standards and Codes

All works shall be constructed in accordance with safe work practices and complying with the relevant adopted Australian Standards, Codes of Practice and the current Building Code of Australia requirements.

## A7 Signage

All signage shall be consistent with the Sydney Olympic Park Authority's *Guidelines for Outdoor Advertising, Identification and Promotional Signage (October 2002).* 

## PART B – PRIOR TO ISSUE OF CONSTRUCTION CERTIFICATE

## B1 Construction Certificate

Prior to commencement of any works, it is necessary to obtain a Construction Certificate. A Construction Certificate may be issued by the Consent Authority or an Accredited Certifier in accordance with the requirements set out in Section 81A of the *Environmental Planning and Assessment Act 1979*. Plans and documentation submitted with the Construction Certificate are to be amended to satisfy all relevant conditions of this consent.

## B2 Principle Certifying Authority

Works is not to commence until a Principal Certifying Authority (PCA) has been appointed, as set out in Section 81A of the *Environmental Planning and Assessment Act* 1979.

## B3 Structural Engineer

The structural bracing and fixing system shall be designed by a suitably qualified Structural Engineer, in accordance with the Building Code of Australia and all relevant Australian Standards.

## B4 No Obstruction of Public Domain without a Works Permit

Prior to issuing a Construction Certificate, the proponent is to obtain a Work Permit to occupy the public way, footpaths, road reserves and the like, which must not be obstructed by any mobile cranes, materials, vehicles, refuse, skips or the like, under any circumstances, unless in accordance with the Works Permit. Non-compliance with this requirement will result in the issue of a Notice by the Authority to stop all work on the site.

# PART C – DURING CONSTRUCTION

## C1 Pollution Management

All noise, water, waste or air pollution activities generated by the development shall be managed in general accordance with the most recent NSW Office of Environment and Heritage guidelines and polices and relevant NSW legislation, including but not limited to, the *Protection of the Environment Operations Act, 1997.* 

# C2 No Obstruction of Public Way

The public way and road reserves must not be obstructed by any materials, vehicles, refuse, skips or the like, under any circumstances unless in accordance with a Works Permit. Non-compliance with this requirement will result in the issue of a notice by the Authority to stop <u>all</u> work on the site.

## C4 Works in accordance with the Building Code of Australia

The works shall be in accordance with the provisions of the Building Code of Australia (BCA) 2011 and any relevant Australian Standards.

Note: Sufficient information must be forwarded to the Certifying Authority illustrating compliance with the relevant requirements of the BCA and *Australian Standards*. Sufficient information may include (but not limited to) reports or certifications issued by an appropriately gualified person.

## C5 Work Health and Safety Act 2011

All works are to be carried out in accordance with the NSW Work Health and Safety Act 2011 and the Regulation 2011.

## C6 Hours of Work

All works (including site deliveries) shall only be carried out between the following hours:

- 1. 7.00am to 5.00pm on Monday to Fridays (inclusive)
- 2. 7.00am to 3.00pm on Saturdays
- 3. No work on Sundays and Public Holidays (except with the prior written consent of SOPA's General Manager Operations and Sustainability).

## C7 Structural Inspections

The Structural Engineer shall perform adequate structural inspections of the sign bracing and fixing system during the sign erection process.

## PART D – PRIOR TO ISSUE OF OCCUPATION CERTIFICATE

## D1 Structural Certification

The Structural Engineer shall provide certification upon completion of erection of the sign(s). This certification shall state that the sign(s) has been erected in accordance with the design and is fit for purpose.

## D2 Occupation Certificate

Occupation Certificate is to be issued by the Principal Certifying Authority (PCA) upon completion of the new signage works in accordance with the requirements of Section 109H and 109M of the Environmental Planning and Assessment Act 1979.
