I strongly agree that revitalising Hornsby Town Centre is necessary to meet the housing demands imposed by the state government. However, the ability to meet these demands through the delivery of the Town Master Plan is entirely dependent upon securing funding from the State Government which is yet to be advised.

Whilst the State Government had demanded the delivery of 5,000 dwellings, they are yet to announce how much of the \$520 million for councils will be allocated to Hornsby in order to deliver this ambitious plan.

I do not want to see my area overrun by high-density dwellings without any new and extensive infrastructure, open spaces, or community amenities.

Despite the state's housing crisis, apartment prices in Hornsby have stagnated or declined in recent years. The previous Council approved the development of apartment blocks by questionable developers which were constructed poorly and have faced constant rectification orders, resulting in depreciating value. Introducing thousands of additional apartments where demand is low is illogical.

There is no point building 36-storey high apartment blocks if no one even wants to live in the 5-storey one next to it.

The Town Centre must be transformed into a livable and appealing place to live through the development of such amenities in order for this rezoning and Master Plan to have any benefit to the residents.

Regarding the rezoning of the Town Centre, as with the Town Master Plan, my primary concern is the proposed increased building heights within the 'retail core' precinct. This would result in towering high-rise buildings adjacent to four-storey apartment blocks that have been part of Hornsby since the 1960s. Expanding the Westfield block's density will adversely affect residents on Sherbrook Road, Burdett Street, Florence Street, and surrounding areas by blocking sunlight, reducing property values, and diminishing the area's quiet charm.

The priority needs to be on cascading building density outward from the town centre. Having 4-storey apartments blocked out by 36-storey apartments is a tragedy for existing residents and an eyesore for visitors.

I firmly believe that the rezoning needs to consider the current demand of real estate in the Hornsby area, and the vital need for infrastructure and amenities in order to make it worthwhile for current and future residents. The development of the Town centre needs to consider the low-density apartment surrounds and the current residents.

underutilising the prime position near the station (located between 200-540m from the proposed northern entrance) and the massive Hornsby quarry park due to open soon, which will make the area a more appealing place to live.

To maximise housing potential and create a vibrant town centre, I propose increasing the height limit in the proposed 16m height zone to at least 41m, aligning it with the adjacent proposed heights. This, along with an adjusted floor/space ratio, will allow for taller residential buildings, creating the most homes for our community.

As a young professional struggling with a long commute into Hornsby CBD due to unaffordable housing, I urge you to consider my input and support for this project. This rezoning offers a sustainable solution to the city's housing crisis, focusing on density near public transport without urban sprawl.

I am excited to consider the revitalisation of Hornsby, but I have some real concerns with the plan:

I am very concerned about the lack of public park space provided in the design. Hornsby already has limited park spaces for playing, meeting and picnicking and the few very small parks proposed on the

plan will NOT provide enough recreational space for the thousands of new residents, many of whom will be young families.

Both adults and children need easy access to grassed areas and trees. Children need space to run in safety. The new Hornsby Square will be a small area close to shops, and I am glad to see it in the plan but it is unlikely to be a play area as such. The existing cenotaph park is not child-friendly (and perhaps frequented by drug-dealers). It is hard to imagine it being revitalised in a way that would encourage its use in that location, surrounded by roads and trainline. I would hope the park in Burdett St would include a playground. The Hornsby Quarry park will provide recreational space for many, eventually, but will also likely be an attraction for those outside the Hornsby town centre area so might be crowded, and is perhaps not a destination for a short break outside.

As a teacher I see firsthand the need for children to run and explore in nature. This town plan will encourage hundreds of families to stay indoors or to shop constantly in a more-crowded Westfield, because there are not enough outdoor options. Please consider the well-being of our future children. I would like to see an open space provided every two blocks, with so many residencies planned.

My other concern regards schooling for all the new families living in Hornsby Town Centre. Hornsby North Public School is already overcrowded and stretched for resources. Hornsby South has less students, but neither school is in walking distance of the town centre. Traffic is already congested heading south on weekday mornings with Barker College parents. Children travelling to either school by bus from these new apartments will need safe access to safe bus stops. Perhaps the solution is for Jersey St land to be be sold to the Department of Education to open a school close to site of the original Hornsby Public School?





In May 2023 Hornsby Council increased parts of Ashley Street to higher density R4 zoning. In the meantime, just across the road, all the properties on the west side of Ashley Street remain R2 zoning, which is only 600m from the Hornsby Train Station as you can see in the zoning map below.

3.3 Development staging

The rest of Ashley Street should be rezoned to high density not only because of our willingness but also because Hornsby Council would not be able to deliver enough homes for the proposed population growth. According to Hornsby Town Centre Review, the development will take 5~10 years even in ideal condition which will be far behind the State government schedule, not to mention it's unrealistic to knock down & rebuild those commercial properties within the B4 zone around the train station since historically there are barely any land-selling records in the past, not to mention the owner's expectation that the acquisition cost would dramatically increase once the current Town Center plan gets proceeds.

On the other hand, there is little potential on the recently rezoned R3/R4 land on the western side of Hornsby station, As there are already fully established townhouses/unit buildings in these areas which are unlikely removable.




