The exhibition period of the application and modification report for <u>s75W modification application MOD 4 to Concept Approval MP 08_0234 Bilambil Heights</u> concluded on Thursday 17 April 2025. ATTACHMENT A - SUMMARY OF MATTERS RAISED BY AGENCIES AND PUBLIC SUBMISSIONS

1. NSW Department of Climate Change, Energy, the Environment and Water – Water Group

1. Ensure that future development proposals consider the controlled activity approvals guidelines.

2. Heritage NSW (Aboriginal Cultural Heritage)

- 1. Prepare an Aboriginal Cultural Heritage Assessment Report (ACHAR) in accordance with current guidelines and standards
- 2. RAPs/LALC consultation was 4 & 15 years ago: Restart consultation.

3. Public submissions

- 1. Roads and traffic
 - Existing roads (namely Kennedy Rd and Scenic Dr) flood, are in poor condition and are dangerous
 - Kennedy Dr cannot accommodate proposed construction weight and ongoing demands
 - Existing roads must be fixed and improved first
 - Another road out of Bilambil Heights is required, including bike path/lane
 - Object to proposed access from McAllisters Rd
 - The 2017 Tweed Shire Road Development Strategy does not support development within the Rise/McAllister urban release area (URA) without the Scenic Drive Diversion, extension to McAllisters Rd and Cobaki Pkwy
 - The proposal must coordinate with development applications being prepared for 300 McAllister Rd & 147 McAllister Rd

2. Infrastructure

- Existing power outages
- Stormwater runoff, erosion and flooding
- Existing poor mobile phone reception
- Sewer, power, drainage and roads should be considered
- Inadequate bus services
- Lack of supermarkets, schools and other essential utilities

3. Built form

- 3 and 4 storeys
- Ridgeline location
- Character
- Overlooking, overshadowing, view loss
- Insufficient setbacks; Request for perimeter roads

4. Other

- Existing green space proposed to be removed
- Existing specific drainage easement
