Introduction

In March 2024, the Minister for Planning and Public Spaces and the Minister for the Environment jointly announced a range of measures to enhance the biodiversity outcomes of the Cumberland Plain Conservation Plan (CPCP). We are also taking this opportunity to make some updates to the CPCP Mitigation Measures Guideline (MMG) in response to implementation issues and feedback on the planning controls. These updates include:

- improvements to the usability and scalability of the MMG
- the application of the MMG to all certified urban capable land
- improvements to clarify specific measures in the MMG.

Once the updated Guideline is finalised, minor changes to references in the *State Environmental Planning Policy (Biodiversity and Conservation) 2021* (**B&C SEPP)** and Ministerial Direction 3.6 will be required to give effect to the updated MMG.

Proposed changes to Mitigation Measures Guideline

In March 2024 the Minister for Planning and Public Spaces and the Minister for the Environment jointly announced 8 enhancements to the CPCP. These enhancements included a recommendation to provide precinct level guidance about protecting native vegetation and the benefits of co-locating open space and parks with existing vegetation.

In response to this, "Part 1 Strategic Planning" of the draft updated MMG includes further guidance on the co-location of open space and parks with existing vegetation or other biodiversity values on certified urban capable land. The strategic planning guidance will assist in ensuring commitments, actions and mitigation requirements for development within the certified urban capable land are achieved.

The current MMG applies to the Greater Macarthur Growth Area and the Greater Penrith to Eastern Creek Investigation Area. For other nominated areas, the mitigation measures are in the relevant DCP.

It is proposed to apply the CPCP mitigation measures for certified urban capable land wholly through the MMG. This will remove those provisions from the state led DCPs below, providing a single point of reference for the CPCP mitigation measures:

- Wilton Growth Area Development Control Plan 2021
- Mamre Road Precinct Development Control Plan 2021
- Western Sydney Aerotropolis Development Control Plan 2022.

Additional changes to these DCPs are also proposed to reflect the date of the Commonwealth approval of the CPCP, and to refer to the application of the updated MMG on all certified urban capable land.

The department is proposing several changes to better support the MMG's implementation, including to scale the application of measures according to biodiversity impact and to enhance the useability of measures through additional guidance (see **Appendix A** for detail). The draft updated MMG also creates a new mitigation measure to comply with the Design Guidelines for Koala-exclusion Fencing (once finalised).

In updating the MMG, the department consulted with councils on issues related to applying the guidelines. The department has also received periodic feedback from a range of other stakeholders. Details of all the proposed changes to the MMG are provided in **Appendix A**.

Related changes to B&C SEPP and Ministerial Directions

Once the updates to the guideline are finalised, a minor amendment to Section 13.16(2) of the B&C SEPP will be required. A provision will also be introduced in Ministerial Direction 3.6 to give effect to the new guidance in "Part 1 Strategic Planning" of the updated MMG for rezoning proposals. This will deliver on the announced enhancement to provide further guidance on the co-location of open space and parks with existing vegetation on certified urban capable land.

Background

The Cumberland Plain Conservation Plan

The CPCP obtained NSW State approval in August 2022 which provides biodiversity certification under Part 8 of the *NSW Biodiversity Conservation Act 2016* (**the BC Act**) and Commonwealth approval in March 2024 which provides strategic assessment under Part 10 of the Commonwealth *Environmental Protection and Biodiversity Conservation Act* (**EPBC Act**).

The CPCP provides the biodiversity approvals required for new development in four nominated areas in Western Sydney and supports the delivery of major transport infrastructure across the region. These nominated areas are Greater Macarthur Growth Area, Wilton Growth Area, Western Sydney Aerotropolis and Greater Penrith-Eastern Creek Investigation Area. The CPCP is part of the NSW Government's commitment to deliver the Western Parkland City, consistent with the Greater Sydney Region Plan: A Metropolis of Three Cities and Western City District Plan.

The CPCP's vision is to enable growth in Western Sydney to 2056 and to deliver important development and biodiversity outcomes. This means it will support the planned and strategic delivery of infrastructure, housing and jobs for Western Sydney while protecting and maintaining important biodiversity areas. This includes protecting, among others, the Southern Sydney koala population, the Cumberland Plain Land Snail, foraging habitat for the Swift Parrot and significant plants like the Nodding Geebung and Spiked Rice-Flower.

The CPCP will achieve this through a conservation program that includes 26 commitments and 131 actions designed to improve ecological resilience and protect biodiversity. The conservation program will seek to address impacts at a landscape scale. Understanding and protecting the environment at this scale will help safeguard Western Sydney's natural environment over the long term and in response to climate change.

What is the Mitigation Measures Guideline?

The MMG sets out mitigation requirements that identified development must address to ensure consistency with the CPCP's biodiversity approvals. These guidelines apply to development under Part 4 of the EP&A Act carried out on land identified as certified urban capable land under Chapter 13 of the B&C SEPP. These guidelines also apply to development on land identified as certified major transport corridors under the CPCP.

The MMG includes specific mitigation measures relating to koalas and threatened ecological communities and species.
