Description of development

The proposal involves the installation of a double-sided digital advertising monopole sign, to the north-west of the Homebush Bay Drive Overpass, Rhodes, within the T9 Northern Line rail corridor. The signage structure would measure 12.58 m wide x 3.95 m high, mounted on a 13.21 m high monopole. The signs would face east and west to Homebush Bay Drive.

The application is integrated development requiring concurrence from Transport for NSW (Roads and Maritime Services) under Section 138 of the *Roads Act 1993*, due to the erection of the sign over a public road, being Homebush Bay Drive.
