CASA has reviewed the 'PRELIMINARY AERONAUTICAL IMPACT ASSESSMENT MOD 9 for Central Barangaroo' by AVLAW of 15 November 2021.

CASA has no objection to the proposed development and no issues with the Aeronautical Impact Assessment.

The Aeronautical Impact Assessment advises the maximum height of the tower crane will be 163.7 above AHD.

The proposed tower crane will infringe the Obstacle Limitation Surface (Outer Horizontal Surface) for Sydney Airport. Therefore, an approval under the Airports (Protection of Airspace) Regulations 1996 from the Department of Infrastructure Transport, Regional Development and Communications will be required. Applications can be made through Sydney Airport by email at: airspaceprotection@syd.com.au. CASA will then conduct a detailed assessment make specific recommendations (if any) at that stage. It is noted that the nearby Crown building is much taller than the proposed tower crane, and the crane for the Crown building was about twice the height of the proposed tower crane.
