#### Overview

As part of the Department's commitment to improving the ePlanning Digital Services on the NSW Planning Portal, we regularly deploy fixes where required and introduce minor enhancements to APIs to support policy changes. These deployments occur on a monthly schedule and are backward compatible, meaning that code changes are not required at the stakeholder end.

This month's release note captures all fixes and enhancements that have been deployed under each digital service API. Some items may require configuration changes on the part of the stakeholders – see table below.

Please note that this document is designed to support the technical staff responsible for the maintenance of stakeholder APIs. It ensures that the integration between the ePlanning Portal and stakeholder IT systems continues to improve.

#### Inbound - Conditions of Consent - Council to eplanning API

- AllConsentConditions This operation retrieves all of the active conditions available
  in the DPE Condition library and Council specific Condition library.
- CouncilLibrary This operation allows the consent authority to add, update or delete
   Bespoke conditions to the Council's condition library.
- ConsentConditions -This operation overwrites all the conditions specific to a
  development application. During Mod and Review of a DA, if any condition needs to
  be retained from the previous determination, then the Condition ID should be passed
  as stored in the previous case.
- GenerateNOD This operation allows the consent authority to validate and save the
  fields required for generating Notice of determination for a specific case (either draft
  version or final version) or validate and save the fields required for generating review
  letter if it is a review of a DA. The generation of NOD will happen offline and once the
  NOD is generated, ePlanning system will notify using the NotificationOfNODStatus
  API
- **SanitizeData:** This operation allows the consent authority to sanitize the conditions data to validate the request payload.
