On 16 March 2022 the delegate of the Minister for Planning granted consent for the development application DA10629 for External alterations to existing tourist accommodation buildings as outlined in Condition A.2 in accordance with Part 4 of the *Environmental Planning and Assessment Act 1979* (the Act).

The development consent is subject to conditions, which are available on the NSW Planning Portal. The consent has effect on and from 16 March 2022.

General Terms of Approval for a Bush Fire Safety Authority under Section 100B of the Rural Fires Act 1997 from NSW Rural Fire Service is incorporated into the conditions of consent.

Reviews/Appeals

Certain appeal and review rights are available to applicants and objectors following determination of a development application.

The applicant has a right to request a review of the determination under section 8.3 of the Act.

If the applicant is dissatisfied with the determination of the application, the applicant has the right, under section 8.7 of the Act, to appeal to the Land and Environment Court within 12 months of the date the determination was notified or registered on the NSW planning portal.
