# **Integration API Release Notes**

December 2021



#### Overview

As part of the Department's commitment to improving the ePlanning Digital Services on the NSW Planning Portal, we regularly deploy fixes where required and introduce minor enhancements to APIs to support policy changes. These deployments occur on a monthly schedule and are backward compatible, meaning that code changes are not required at the stakeholder end.

This month's release note captures all fixes and enhancements that have been deployed under each digital service API. Some items may require configuration changes on the part of the stakeholders – see table below.

Please note that this document is designed to support the technical staff responsible for the maintenance of stakeholder APIs. It ensures that the integration between the ePlanning Portal and stakeholder IT systems continues to improve.

# **BIC APIs Overview**

The following enhancements have been delivered in the November 2021 release.

# **Key Features**

Description	Digital Service/API
Building Information Certificate Integration APIs - NEW	Building Information Certificate
The Department has developed inbound and Outbound APIs to facilitate the flow of Building Information	
Certificate requests between ePlanning and various organisation's IT systems.	
Building Information Certificate is specifically intended for applicants to lodge their BIC applications to councils.	
The following Inbound/Outbound/Common APIs have been incorporated to facilitate the operations mentioned in the corresponding descriptions.	
Outbound - Building Information Certificate - ePlanning to council API	

- CreateBIC This operation transfers the building information certificate details entered by the applicant from the building information certificate digital service to the council's IT system.
- **UpdateBIC** This operation updates the application details entered by the applicant from the Building information certificate digital service to the council's IT system.
- **ResponseToDeferredDetermination** This operation transfers the response by the applicant on deferred determination by council from the building information certificate digital service to the council's IT system.

### Inbound- Building Information Certificate - Council to eplanning API

- AcceptReturn This operation transfers the council's decision, to accept or return the application, from council's IT system to the building information certificate digital service.
- Assessment This operation transfers the council's assessment details from council's IT system to building information certificate digital service.
- **DeferDetermination -** This operation transfers the deferred decision by council from the council's IT system to building information digital service.
- CloseDeferredDetermination This operation transfers the decision by council to close deferral case from the council's IT system to building information digital service.
- **Determine:** This operation transfers the determination decision by council from the council's IT system to building information digital service.
- InitiateInspection This operation transfers the inspection initiation details from council's IT system to building information certificate digital service.
- **PerformInspection** This operation transfers the inspection details from council's IT system to building information certificate digital service.

**CompleteInspection** - This operation transfers the inspection completion details from council's IT system to building information certificate digital service.

#### **Common Outbound APIs**

- UpdateAdditionalInfo This operation transfers additional information uploaded by the applicant from ePlanning to the relevant council's IT system. This additional information could either be provided voluntarily by the applicant or as the result of a request from the relevant council.
- **Reassign -** This operation updates the relevant organisation on assigning or reassigning of the case.
- Withdraw This operation transfers the applicant's decision to withdraw the application to the relevant council's IT system.
- **Documents -** To download a document attached to the application.

### **Common Inbound APIs**

- GetCaseInfo This operation enables the relevant council to request ePlanning to resend the application details from the planning portal to their IT system.
- Reassign This operation transfers the reassignment details to eplanning on a case when the case is reassigned from one user to another user within the relevant organisation.
- ReqAddInfo This operation enables the relevant organisation to request the applicant to provide additional information to the ePlanning from their IT system.
- **Documents** This operation enables the external organisations to request documents available in planning.

- Withdraw This operation transfers the relevant organisation's decision to withdraw the application from their IT system to the ePlanning.
- CloseAlCase This operation transfers relevant organisation's decision to close an additional information case to the ePlanning from their IT system.
