Dear Transport for NSW and Ingham Property Group,

I am writing to express my profound dissatisfaction and anger regarding the proposed IPG Badgerys Creek Road Master Plan, as communicated in your letter dated 15 November 2024. It is utterly unacceptable that neither Transport for NSW nor Ingham Property Group reached out to me directly impacted by this plan prior to its public announcement. This oversight shows a blatant disregard for our rights and interests as owners in this community.

The lack of communication from both parties is not just disappointing; it is infuriating. We deserve to be informed and included in discussions that directly affect our properties. Instead, we have been left in the dark, forced to scramble for information about a plan that could have significant ramifications for our homes and businesses. Your failure to reach out to us demonstrates a lack of respect and consideration for our concerns.

The proposed changes outlined in your letter, including the potential adjustments to the intersection of Badgerys Creek Road and the planned Eastern Ring Road, are alarming. The prospect of increased property acquisitions without prior discussion or consent is unacceptable. It is unacceptable that Transport for NSW and Ingham Property Group would move forward with such significant plans without engaging with the very people who will be most affected.

As such, I formally reject the proposed IPG Badgerys Creek Road Master Plan in its current form. I demand that you reconsider this plan and engage with me. It is imperative that our voices are heard and that we are treated as valued members of this community, not as afterthoughts in your planning process.

I expect a prompt response to this letter, addressing my concerns and outlining how you intend to rectify this situation. Failure to do so will leave me with no choice but to escalate my objections further.
